3. INTRODUCTION

3.1 The Limpopo Department of Health herein invites competent and /or self-reliant companies for supply and delivery of perishable provisions in the Limpopo Department of Health at competitive prices, efficiently, timeously and dependably.

4. BACKGROUND

4.1. The vision of the Limpopo Department of Health (LDoH) is to provide value-based procurement services at all Hospitals that will promote equal access to healthy and nutritious food. These foods will include perishable foods items, which are beneficial to human health and contribute to a healthy diet that aids in the provision of quality patient care.

4.2. The Limpopo Department of Health herein invites competent and /or self-reliant companies for supply and delivery of perishables in the Limpopo Department of Health at competitive prices, efficiently, timeously and dependably.

5. SCOPE OF WORK

5.1 The provision of health care services follows the specified legislative requirements, policies and procedures that needs to be adhered:

5.2 In accordance with National Health Act, 2003: Norms and Standards Regulations in terms of Section 90 (1)(B) And (C) of the National Health Act, 2003 (Act No. 61 Of 2003), applicable to certain categories of Health establishments:

5.3 The Limpopo Department of Health (LDoH) intends to appoint a service provider that will supply and deliver perishable provisions to various Hospitals from time to time, based on their required food supplies.

5. SPECIAL CONDITIONS OF CONTRACT (SCC)

INSTRUCTIONS

- 5.1. The successful supplier will be bound by Government Procurement: General Conditions of Contract (GCC) as well as this Special Conditions of Contract (SCC), which will form part of the signed contract with the successful supplier. However, LDoH reserves the right to include or waive any condition in the signed contract.
- 5.2. The signed contract, which is inclusive of the GCC, SCC and Technical Specification shall be signed 7 days after the award of the bid. The SLA which is regarded as performance agreement by the LDoH shall be negotiated with the end-user and signed-off 30 days after signing of the contract with the Accounting Officer.
- 5.3. LDoH reserves the right to –
 - 5.3.1. Negotiate the conditions, or
 - 5.3.2. Automatically disqualify a bidder for not accepting these conditions
 - 5.3.3. Award the bid to multiple bidders.
- 5.4. In the event that the bidder qualifies the proposal with own conditions and does not specifically withdraw such own conditions when requested upon to do so; LDoH shall disqualify the bid.

9. Categories of Product

9.1. The award of the bid per institution is categorised as follows:

10. THE BID ALLOCATION STRUCTURE:

- 10.1. The bid shall be awarded and allocated in accordance with the number of hospital beds and in terms of specific goals and Price ranking.
- 10.2. There shall be one or more bidders allocated per hospital for Category A, B and C respectively.
- 10.3. The price of the overall winning bidder shall be utilized to allocate the bid in terms of 10.1 above.
- 10.4. The overall winning bidder shall be allocated the biggest hospital in terms of bed capacity and category of products.
- 10.5. The price negotiation shall be engaged with the eventual winning bidder.
- 10.6. The bid may be passed from second to the lowest scoring bidder on condition that they accept the winning bidder's price (limited to the available clusters/facilities).
- 10.7. In circumstances where any of the bidders (whom the bid has been passed) fails to accept the bid offer, the proposed clusters/facilities to be reallocated to the eventual winning bidder.
- 10.8. The eventual winning bidder shall be allocated the cluster with the highest number of hospitals beds, and the rest shall be allocated on a sliding scale of a number of hospital beds and scoring rank in terms of price and specific goals.

11. KEY ASPECTS OF THE BID PROPOSAL

Bidders must take note of the following fundamental aspects before submission of their bid proposals:

- 11.2. In order to evaluate and adjudicate bids effectively, it is imperative that bidders submit responsive bids. To ensure a responsive bid it is imperative to comply with all conditions pertaining to the terms of reference.
- 11.3. Each bidder must attach all applicable documents in support of its bid in accordance with the requirements set out in this bid as well as any other relevant materials, photographs and/or attachments.
- 11.4. The department reserves the right to verify any information supplied by the bidder and should the information be found to be false or incorrect, the department will exercise any of the remedies available to it.
- 11.5. Each bid, once submitted, constitutes a binding and irrevocable offer to provide the services on the terms set out in the bid, which offer cannot be amended after its date of submission.
- 11.6. The department reserves the right to invite any bidder for a formal presentation during the evaluation process.

12. BID AWARD & CONTRACT CONDITIONS

- 12.1. The shortlisted bidders shall be subjected to Supply Chain Management and State Security Agency screening processes and only successful bidders who are cleared during screening shall be considered for appointment.
- 12.2. The department is not obliged to accept or consider any bid in full or in part or any responses or submissions in relation thereto and may reject any bid.
- 12.3. The award of the tender may be subjected to price negotiation with the preferred bidders.
- 12.4. The department reserves the right to award the bid to one or more service providers, at negotiated rates, wholly or in part or not to award. The bid shall be shared through the passing of the bid to other bidders according to point scoring ranking for price and specific goals.
- 12.5. In case where any prospective bidder who have been allocated the award in terms of clause 10.4 above declines the award, the allocated cluster/s to be re-allocated to the overall winning bidder.
- 12.6. The price of the overall winning bidder may be used for the purpose of passing the bid. The strategy to pass the bid shall be based on the Price and Specific Goals (PPR 2022) points ranking from highest to the lowest points.

12.14. During the contact term the department may either add or close down the facility according to its need.

13. PRICE REASONABILITY TESTING AND MARKET RESEARCH

- 13.1. The department may, on reasonable and justifiable grounds, award the bid to a company that did not score the highest number of points.
- 13.2. The department shall conduct the market research to determine if bidders did not underquote their price offers.
