Opening and welcome

BoM welcomed all attendees and thanked all attendees for taking time to attend the Compulsory Briefing Session, apologies for technical glitches were conveyed and BM further introduced herself as the procurement lead for this project and requested all attendees to introduce themselves starting with Transnet colleagues and prospective bidders.

After the opening and welcome BM was still experiencing technical issues, Andile Ntloko then requested the meeting to reconvene at 11:00 am to allow for the technical issues to be resolved.

The reconvened at 11:00 am

Confirmation of the agenda

Bongi Machi took the attendees through the agenda.

Rules of engagement

(BM) noted that this briefing session is compulsory and was voice recorded. Bidders who failed to attend will be disqualified.

(BM) requested that all bidders remain for the entire duration of the briefing session as important information pertaining to the RFP would be presented.

Emphasis was made on the submission of the signed section 10: certificate of attendance of compulsory briefing session.(BM) further stated that the briefing session presentation will be uploaded to the Transnet e-tender portal and NT etender portal. For full details on the session rules of engagement (**Refer to Annexure A-The Briefing Session Presentation**).

Project background and overview

(Jerome Thambu) gave attendees the background of the project at high level as per the scope of work.

Procurement process / Tender Process

(BM) presented information on the tender process and highlighted all the sections and annexures and key emphasis on closing date, returnable mandatory returnable.

Emphasis was made on the process of tendering and Tenderers were advised that they are required to ensure that electronic bid submissions is submitted timeously to prevent issues which they may encounter due to their internet speed, bandwidth or the size of the number of uploads they are submitting. Transnet will not be held liable for

any challenges experienced by bidders as a result of the technical challenges. Please do not wait for the last hour to submit. A Tenderer can upload 30mb per upload and multiple uploads are permitted.

(BM) took bidder through all the steps of the evaluation methodology stages asked bidders to ensure that they submit valid mandatory returnable, allocation of specific goals and the importance to submit timeously as late submissions will not be considered. For full details on the Tender Process. **(Refer to Annexure A-Briefing Session Presentation).**

Technical Scope & requirements

(AM) took bidders through the scope of work.

(JT) advised bidders on the minimum threshold which is 66.67 points for bidders to progress to the next evaluation stage. And further took bidders through the key elements that will be evaluated, which are:

- The experience of the specific supplier, the number of years that the manufacturer has been which must be coupled with references.
- Delivery times.
- Testing of the warranties
- And compliance to annexure B

Bidders were advised to thoroughly peruse the RFP document in order to be familiar with the evidence (proof) to be submitted for each criteria.

(Refer to Annexure A-Briefing Session Presentation).

Pricing schedule

(NM) took bidders through each line items in the pricing schedule with emphasis to different options for shipment, and insurances involved. (MM) further emphasized the point of the bidders to go through scope of works before completing the pricing schedule.

NIPP

(AL) took bidders through the NIPP requirements.



Questions and Answers

Questions and answers received during the briefing session	
Bidders were given an opportunity to ask questions or clarify issues as they required:	
Q1	Due to the significant amount of work required in the RFP, and the documentation can Transnet kindly consider extension of the deadline to 14 December 2023.
A1	The extension of closing date was considered (from 30 November 2023 to 13 December 2023) and the addendum thereof to be published.
Q2	confirmation that the incoterms will be applied to the whole scope of work of the of the RFP.
A2	It was confirmed by Transnet National Ports Authority that the CIP incoterms apply to the whole scope of works of the RFP.
Q3	Specification from the Port of Durban and the Port of Richards Bay are exactly the same can we only quote for one set of tools
A3	Complete and quote for all 3 helicopters for their respective Ports even though the specification is the same for Durban & Richards Bay per RFP requirements.
Q4	By when would the training be required and can it be undertaken in an accredited third country facility
A4	Training can only be planned once the tender has been awarded. All training must take place at a certified accredited OEM
Q5	Tender is for new aircraft and not open for any other option like refurbished and lease
A5	The tender is for new aircraft
Q6	Requires OEMs only – this means there is no space for SA and specifically for black participants in this bid
A6	The tender is for design, manufacture and supply to our specific specification for Helicopter Marine Pilot Transfer Service.

Q7	Based on the above, and without inferring who the particular OEM is, a review of the specification is that is it not capability specific / a generic user requirement statement. Rather, it is aligned with a specific OEM offering and TNPA is requested to have this independently reviewed and revert with findings prior to the closing date
A7	Any OEM who is in the aircraft building space can be able to manufacture the marine pilot helicopter according to the TNPA specification
Q8	Considering the tender requirement – design, supply, commissioning, testing and delivery – any OEM’s production schedule, registration requirements, shipping requirements etc. The 18 months period does not seem practical unless the OEM already has the aircraft manufactured and are simply ready for complying with the tender conditions - so the question is if this period can be extended too
A8	This period cannot be extended due to the project being delayed for years
Q9	Why design if there is compliant products in the market
A9	This provides an option and greater opportunity to OEM’s that do not have compliant products already in the market and also to SA participants
Q10	360 degree slope deck. please elaborate
A10	This requirement is for when we land-on ship decks that are pitching and rolling in all directions i.e: 360 degree axis
Q11	There is an argument to made pertaining to the supply of a used platform. Especially if supplied by an OEM approved supplier and in particular that the machines/s will come with a maintenance reserve program (Engine, Airframe, Hoist etc) effectively covering all items at an acquisition cost considerably lower than new with all the warranties and guarantees etc in place same as new and more readily available within the time frames indicated. Perhaps this question needs to addressed effectively via email to all participants for clarity. thank you.
A11	The tender is for new aircraft

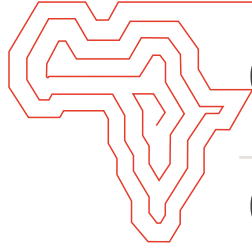

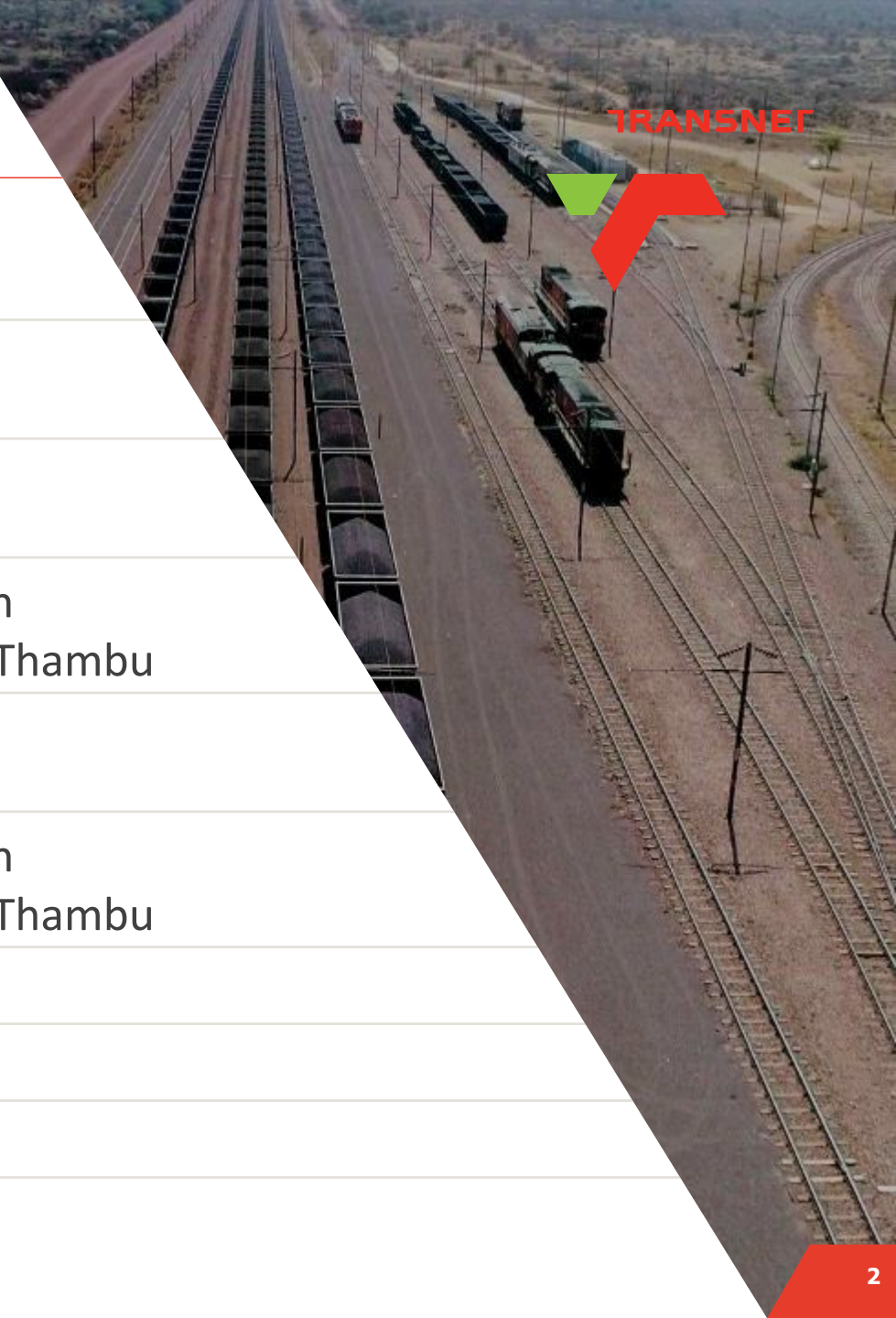

The tender closes at the Transnet e-Tender Submission Portal: www.transnet.net on Thursday 30 November 2023 at 14:00 (CAT).

TENDER SUBMISSION Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

- The Transnet e-Tender Submission Portal can be accessed as follows:

- Click on “ADVERTISED TENDERS” to view advertised tenders;

Step 1 - Administrative responsiveness

- Whether the bid has been lodged on time.
- Whether all Returnable Documents were completed and returned by the closing date and time.
- Verify the validity of all Returnable Documents.



Step 2 - Substantive responsiveness

- Whether the Bid contains a Financial offer.
- Whether bidder meet Technical Pre-qualification Criteria/minimum requirements and submitted EASA (European Union Aviation Safety Agency)/FAA (Federal Aviation Administration) Type Certification Data Sheet (TCDS) to operate under Category A, Performance Class 1 or higher.
- Whether bidder attended the Compulsory Tender briefing and submitted section 10: certificate of attendance of compulsory RFP briefing that is signed by the Employer's Representative.



Step 3 - Functionality:

The minimum qualifying score for functionality is **66.67 points** and is discussed in detail in the Technical Presentation.

Only those tenderers who obtain the minimum qualifying score for functionality will be evaluated further in step 4 in terms of price and the applicable specific goals.



Step 4 - Financial offer and Specific goals

Preference Points system is as follows:

- ✓ Price(90); and
- ✓ Specific goals (10)
 - B-BBEE Status Level of Contributor 1 or 2 **(10)**
 - Non-Compliant and/or B-BBEE Level 3-8 contributors **(0)**
 - ***** a score of zero will be allocated should a bidder fail to provide evidence in the form of a B-BBEE certificate**

Specific Goals	Acceptable Evidence
B-BBEE Status contributor	B-BBEE Certificate / Sworn- Affidavit / B-BBEE CIPC Certificate (in case of JV, a consolidated scorecard will be accepted) as per DTIC guideline



Step 5 – Post Tender negotiation

- Bidders are to note that Transnet may not award a contract if the price offered is not market related.
- In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
 - First negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
 - Negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.



Step 6 – Objective criteria

Transnet reserves the right to award the business to the highest scoring bidder/s unless objective criteria justify the award to another bidder. The objective criteria Transnet may apply in this bid process include:

- To award of the contract between more than one Supplier/Service provider, should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations price of the helicopters. TNPA will negotiate any price disparities of the next ranked bidder(s) to ensure price reasonability;



Step 7 – Award of Business and conclusion of contract

- Immediately after approval to award the contract has been received, the successful bidder(s) will be informed of the acceptance of his/their Bid by way of a Letter of Award. Thereafter the final contract will be concluded with the successful Respondent(s).
- A final contract will be concluded and entered into with the successful Bidder at the acceptance of a letter of award by the Respondent.
