4.1 Liability

- 4.1.1 The contractor shall at all times be responsible for the acts and omissions, e.g., death, injury, assault, unlawful unrest, etc. of his employees when they provide any services to the Provincial Government in terms of the bid and act within the course and scope of these duties and employment.
- 4.1.2 The contractor indemnifies and holds the Provincial Government blameless against the damage to property and loss of property of the Provincial Government and any third party that may be involved.
- 4.1.3 It is recommended that the bidder's employees be vaccinated against Hepatitis B. Should the contractor's employees' contract Hepatitis B while providing a service at this facility, the contractor indemnifies and holds the Provincial Government blameless.
- 4.1.4 The successful bidder must adhere to ALL relevant Coronavirus Regulations or any other Highly infectious diseases.

4.2 Important

- 4.2.1 Bidders **must** obtain Comprehensive Insurance and Public Liability Insurance at their own cost commensurate with the risks to which they are exposed. - 4.2.2 Proof of validity of the Public Liability Insurance cover to be submitted on a monthly basis to the Supply Chain Management Unit – Contract Administration Section.

4.3 Advertising and Trading

THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

INTRODUCTION

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade, Industry and Competition (DTIC) is charged with the responsibility of administering the programme.

1. PILLARS OF THE PROGRAMME
