The Free Department of Human Settlements has projects in its business plan that requires the services of contractors who are accredited with National Home Builders Registration Council (NHBRC) and registered with Construction Industry Development Board (CIDB) to undertake housing delivery projects in order to eradicate housing backlog in the Free State Province.
