1 PURPOSE OF THIS DOCUMENT

SABS SECUNDA Laborarory is accredited to conduct Total Sulphur analysis using the SULPHUR analyser on coal samples. The laboratory has a contract with SASOL and ESKOM to conduct this analysis on all Sasol and Eskom samples from their mines for their geological exploration projects. The contracts have clear turnaround time agreements which requires the laboratory to prepare, test and report within a reasonable turnaround time (TAT) with penalty clause for late reporting. To meet customers' requirements, the laboratory needs to have a reliable and available SULPHUR instrument. The laboratory uses two very old SULPHUR machines of more than 10 year old which consistently breakdown and also requiring regular maintenance and repairs to conduct the analyses and meet contractual obligations. The older model instruments will become obsolete as the supplier will no longer support or supply spares for its repairs by end of year 2023.
