First Aid Level 1 – 2 Combined training

Duration:

4 Days (Unit Standard 120496 requires 4 days)

Validity of certificate:

The certificate issued will be valid for the period of three years.

Unit Standard:

<u>Provide risk-based primary emergency care/first aid in the workplace _120496</u> Target Group:

All nominated and/or appointed First Aiders and all employees whose work activities require first aid skills

Purpose:

To equip learners with knowledge and skills to be able to assess the emergency situation and providing basic Life Support and basic First Aid in order to stabilise patients prior to transfer to the emergency services.

Provide basic Life Support and basic First Aid skills in order to minimize the mobility and mortality of injured or ill employees through the application of prompt and appropriate first aid and emergency care at the workplace.

Learning outcomes:

On completion of this course, learners will be able to:

- a) Demonstrate the principles of primary emergency care in the workplace
- b) Demonstrate an understanding of emergency scene management.
- c) Demonstrate an understanding of elementary anatomy and physiology.
- d) Assess an emergency situation.
- e) Demonstrate primary emergency life support for adults, children and infants according to current international protocols.
- f) Apply First Aid procedures to the life-threatening situation and treat common injuries
- g) Conduct secondary assessment of the sick and/or injured person and provide appropriate primary emergency care within the workplace.
- h) Keep records of the incident/accident.
- i) Sustain a basic level of preparedness for health emergencies in the workplace.

Course content:

The course must cover the following:

- a) The objectives of First Aid
- b) Legal and Ethical Consideration Concerning First Aid
- c) Cardio Pulmonary Resuscitation
- d) Dressing, bandages and soft tissues injuries
- e) Secondary Survey
- f) Identify Signs, Symptoms and treatment of the following emergencies and injuries
- g) Choking
- h) Burns
- i) Shock, unconsciousness and fainting
- j) Head and spine injuries
- k) Chest injuries
- I) Abdominal injuries
- m) Bones, Joints and muscle injuries
- n) Eyes and ears injuries
- o) Medical conditions
- p) Poisoning
- q) Animals and Insects bites and sting
- r) Environmental Illnesses

- s) The principles of primary emergency care in all health emergencies for persons in the workplace

- b) Providing CPR (including children and infants)
- c) Potential hazards in the work environment
- d) Wound treatment and bleeding control

- g) Correct equipment and precautions when administering First Aid
- h) How to assist during emergency child birth
- i) Body anatomy

Target Group:

All nominated and/or appointed Evacuation Wardens

Purpose:

The purpose of this course is to train learners in order that are able to identify and determine the type of an emergency and assist with the evacuation of people during the emergency. Also to be able to respond to and use emergency signals within their own area of responsibility

Course contents:

The training course shall address the following aspects:

- a) Definition and categorisation of an emergency and different emergency situation
- b) What kind of emergencies can take place in the workplace, potential threats and risks, for example fire, floods, bomb threats, armed robbery

- c) Emergency planning, structures and evacuation procedures, including the location of services, safety signs, registers etc
- d) The responsibilities of Evacuation Wardens
- e) Evacuation planning
- f) Evacuation action structure
- g) Emergency evacuation training for staff, including evacuation drills and the reporting of emergencies
- h) The evacuation of disabled persons
- i) Post emergency analysis

Fundamentals of Fire Safety training

Duration of training:

1 day

Validation of certificate:

Target Group:

Intended for all employees as part of induction training, those appointed as safety representatives, or those performing basic fire safety duties.

- Appointed fire marshals
- Evacuation officers
- Employees doing technical and mechanical work

Instructor qualifications:

- a) Fire Instructor with necessary competency and knowledge (SAESI Fire fighter 2/FPA or Industrial Fire Fighting Advanced Level and assessors)
- b) Registered as assessor with relevant accreditation body
- c) Group learning facilitation

Venue:

Any suitable site where small controlled fires can be made and classroom facilities are available. Local environmental regulations must be considered when selecting such venues.

Unit Standard:

Demonstrate knowledge pertaining to fires in working places _120331 **Outcome of the course:**

Learners will be able to:

- a) identify a fire emergencies;
- b) identify the class of fire and select an appropriate portable fire extinguisher;
- c) safely use a portable fire extinguisher to safely attempt to extinguish a fire;

- d) identify the possibility and method of fire spread;
- e) know how to report on a fire emergency;
- f) understand and coordinate safe evacuation procedures;
- g) understand symbolic safety signs; and
- h) understand the importance of fire safety at work and in the workplace.
