- Current burst cabinets are old and not sufficient to process the inflow of samples efficiently and effectively. The current burst cabinets are in the process of being scrapped as they have exceeded their lifespan and replacement parts are not available.
- To improve the current poor turnaround time and increase volume of issued test reports.
- To reduce overtime.
- The laboratory intends to attain SANAS accreditation for female condoms according to SANS 25841, therefore this burst cabinet can provide the required operation efficiency.

Condom Inflation Burst Volume and Pressure Testing Equipment is used to perform inflation of a specified length of the condom by carrying out condom burst volume and pressure testing following SANS 4074 and ISO 25841 test standards. Burst volume and pressure testing is conducted with condom burst cabinets. The burst cabinets inflate condoms until they burst. When performing testing, it is prescribed to use the equipment that is suitable for inflating the condoms with clean, oil-free and moisture-free air at a specified rate for measuring volume and pressure at the time of burst.

Furthermore, as a requirement in SANS 4074, the pressure and volume measuring equipment is to achieve expanded uncertainty using a 95% confidence interval of ± 3.0 % for volume and ± 0.05 kPa for pressure.

The equipment is to interchangeably operates both male and female test heads, be automated, maintained by laboratory staff with minimal effort, be fast and easy to operate.

The equipment clamps are to be adaptable to different types of female condoms.
