Tenders may only be submitted on the prescribed tender documents and must include a valid Tax Clearance certificate as well as the Tax Compliance Status <u>PIN</u> as issued by <u>SARS</u>.

Tenders will be evaluated and adjudicated in accordance with the Swellendam Municipality's preferential procurement policy and its Supply Chain Management Policy. The <u>80/20</u>-point system will be applicable. The Council does not bind itself to accept the lowest or any bid and reserves the right to accept a tender in full or a part thereof.

## <u>Pre-qualification / Eligibility Criteria:</u>

- Bidders are required to attend the compulsory site clarification meeting.
- Bidders must obtain a minimum functionality score of 70%.
