Tenders will be evaluated and adjudicated in accordance with the Swellendam Municipality's preferential procurement policy and its Supply Chain Management Policy. The **80/20**-point system will be applicable. The Council does not bind itself to accept the lowest or any bid and reserves the right to accept a tender in full or a part thereof.

- Bidders are required to attend the compulsory site clarification meeting.
- Bidders must obtain a minimum functionality score of 70%.
