TERMS OF REFERENCE – APPOINTMENT OF PANEL OF SERVICE PROVIDER(S) TO PROVIDE PEST CONTROL AND FUMIGATION OF BUILDING STRUCTURES ON AN AS AND WHEN REQUIRED BASIS AT KRUGER NATIONAL PARK FOR THE PERIOD OF FIVE (5) YEARS.

The prospective service provider/s is expected to render Pest Control / Fumigation service as and when required to eliminate infestation of cockroaches, ants, termites, bats, mice, rats, spiders, wasps, bird lice, bed bugs, fleas, flies, critters, snails, millipede centipede, scorpions, army worms, locusts and any crawling or flying insects; removal of bird nests, bees, treatment of mold; snakes and trapped stray animals as well as place bait stations around building structures at Kruger National Park as follows: After business hours i.e 16:30pm or as per the agreed schedule.

Fumigation to be undertaken at all buildings with full reports that must be forwarded to OHS office who will endorse the reports.

All pesticides, insecticides and fumigation substances to be used must be compliant to SABS and SANS code of practice, KNP pest control Standard operating procedure and Department of Agriculture approved.

All pest control services are to be undertaken in compliance with Occupational Health and Safety Act 85 of 1993 in conjunction with Hazardous Chemical Regulations.

If there is a need to utilise other chemicals by the service provider, they should declare.
