- 3. Certified copies of Permission to Occupy (PTO's) land for bidders residing in Tribal Authority's areas of jurisdiction; proof of residence from Traditional Authority).
- 4. Certified copies of Identity Documents (ID's) for all shareholders/owner(s)/partners registered on the CK forms.
- 5. Copies of Company Registration documents (CK 1) must be submitted.

- 6. Bidders must attach a valid tax pin certificate.
