The scope of work will include the purchase, collect and removal of used FRF castrol anvol PE 46B plus or minus 5250 LT from Matimba Power Station. The oil is stored in the big tank and drums. Collection for the oil is at Matimba Power Station.

The purchaser will be responsible for the safe collection, handling, removal, and transportation of the used transformer oil as well as to clean the site, qualified labour and suitable certified plant, machinery, equipment and transport for this purpose.

Payment shall be made to Eskom no later than five days after the date of the sale. The release of the equipment/scrap to the new buyer will take place after receipt of payment to Eskom and the buyer acquiring a permit to remove and transport the equipment/scrap.

The goods on sale will be identified by Eskom.
