## **INTRODUCTION TO SANPARKS**

Table Mountain National Park (TMNP), one of South Africa's most iconic and cherished natural treasures, has consistently welcomed millions of visitors each year, both local and international. As a UNESCO Natural World Heritage Site and a vital component of Cape Town's unique landscape, it is imperative that SANParks, the custodians of TMNP, continually strive to enhance the visitor experience, while also safeguarding the Park's natural and cultural heritage. To achieve this, it is essential that SANParks gain comprehensive insights into the usage patterns of visitors and users of this open access park in terms of the number of people using the Park, what they use it for, why and when.

To manage effectively and plan strategically, it is essential that the Park has access to reliable, comprehensive and updateable information, including visitor and user usage of the Park. Two comprehensive 'Visitor and User Surveys' were undertaken in 2000 and 2007 and the core information from this survey needs to be updated. In addition, new management mandates (Marine Protected Area) require baseline information.

As such SANParks is seeking a research/consultancy team to design and carry out a full-scale Visitor and User Survey to provide the Park with the information required.

It will be necessary for such a survey to be multi-faceted in its design, form and execution. A wide range of different types of data are required from a variety of sources using different survey techniques. Two key types of information are required. Quantitative information is required regarding paying visitors through Park Pay Points, as well as in openly accessible areas used by casual walkers, serious climbers, water sport users, people extracting resources (Marine usage) and so on. Secondly, qualitative information regarding user opinion, needs and priorities should be gathered from a sample of visitor and user groups, to provide the necessary contextual and complementary information to the quantitative database.

The Visitor and User Survey will dovetail with and assist in guiding Park Planning and Strategic Adaptive Management processes. The data generated from this program will be managed as part of the Park's Environmental Information Management System (EIS).

The database compiled through the survey will continue to be the foundation on which sound future decision-making in relation to strategic planning and practical implementation can be based, and without which management cannot operate effectively.

## **2 GOALS**

To conduct a full scale TMNP Visitor and User Survey, over a 12-month period, that will produce the following results:

- Updating the database of quantitative and qualitative information on TMNP



visitors and users, against which future progress and projections can be measured.

- Facilitating effective planning of the range and scale of facilities and services to meet user / visitor needs and Park capacities.
- Prioritising programmes and projects, by identifying 'logjams' and anticipating pressures.
- Measuring the effectiveness of the TMNP's existing management strategy, planning and implementation, in relation to visitor / user needs and expectations and Park capacities.
- Informing the Tourism Strategy: enabling Park management to evaluate their strategy, planning and implementation in relation to visitor / user needs, experiences and expectations.
- Assisting the TMNP to prepare its budget by predicting the number of paying visitors to the Park.
- Measuring and tracking the evolving demographic trends in both the pay areas and the open access areas.
- Providing actionable recommendations and strategies for Park management, including the development of visitor management plans, infrastructure enhancements and conservation efforts, ensuring the long-term preservation and enjoyment of the Park.
- Providing insight into the overall visitor experience, including satisfaction levels, preferred activities, and perceptions of Park facilities, services, and accessibility, with the aim of identifying areas for improvement.

## **CONTRACT PERIOD**

12 Months field and survey work with 3 months post project write-up

## **SPECIFICATIONS/SCOPE OF WORK**

For the purposes of this survey, the visitor and user base of the TMNP comprises the following range:

### **3.1 Visitors:**

- General sightseers and visitors to the Park:

Visitor categories can be further defined very broadly in terms of how and where they access the Park, as follows:

- **High usage areas** are formal, authorised and known entrance points to, and assemblage / dispersal points within the Park used on a daily basis by thousands of visitors.
- **Intermediate usage areas** – informal entrance and assemblage/dispersal points within the Park, which are well used at certain times by smaller numbers of people.
- **Low usage areas** - informal entrance and assemblage/dispersal points within the Park generally of limited and localised use.
- **Marine Gateways** – are formal slipways and key coastal points that are used to access the Table Mountain National Park Marine Protected Area.

(A list of these areas are available and may be further refined by the survey team.)

### 3.2 Recreational Users:

Recreational user groups who access the Park for specific types of activities on an ongoing or regular basis: these can be further defined as follows:

- **Organised user groupings** – clubs, associations, etc. that represent a specific group of users involved with a specified activity, usually at particular places in the Park (such as the Mountain Club of SA, Diving clubs, Hang-gliding, and so on.)
- **Active Park users** – users who participate in a activities as individuals or in non-formalised groupings. 17 different user groups were identified in the 2000 and 2007 surveys.

### 3.3 Specialised Users:

Specialised users make use of the Park though the use of specialised permits. These can be grouped into Special Event permits (e.g. Restricted Area's) and Environmental Education/Outreach permits.

### 3.4 Users linked to commercial activities:

- **Commercial Recreational Events** – organised event permitted for e.g. trail run, mountain bikes, etc.
- **Commercial Filming locations** – organised film and photo shoots permitted

## 4 DATA REQUIRED:

The quantitative and qualitative data of the survey make up the necessary complementary components of the same database. The first is required for estimates and projections of the numbers of people and allied statistics on patterns of usage across the Park, while the second provides the context and rationale for visitor characteristics and usage patterns across the Park. The following overview information is required from the survey:

### 4.1 Quantitative data:

- Visitor / user profile:
- Locality / place of origin; place of residence – local, regional, national, international.
- Demographic variables: gender, age, ethnicity, special needs, and indicators of socio-economic status (selected from certain proxy indicators that can be used, such as place of residence, employment status, education, income)
- Frequency of usage / visits:
- Times of day; days of week; peak / holiday times; off-peak frequencies
- Duration of visit
- Usage type: Active, passive; nature and extent of usage
- Access: Means of access (including modes of transport); points of access (including payment);
- Visitor / user numbers; Future use and demand (Statistical projections)

### 4.2 Qualitative data:

Visitor / user views on levels (index) of satisfaction on current usage and facilities. In the 2000 & 2007 survey the following categories were used, which will be refined in this survey:

overall experience; parking; signage and information; TMNP staff; footpath and walkways; interpretation material (historical, environmental, etc); environmental quality; safety & security,

Understanding a National Park, WHS vs local recreational areas,

Membership to SANParks' loyalty Cards / activity card programme,

Visitor / user needs: Priorities, evaluation, suggestions

## 5 METHODOLOGY - CRITERIA:

The approach used must provide the Park with a methodology that meets the following criteria:

**Replicable** - the methodology for data gathering can be used by the Park on an ongoing, long-term basis. It must allow for inter-survey comparisons, facilitating longitudinal studies over time that accurately determine changes in the visitor / user numbers and respondent perceptions and attitudes.

**Updateable** – the methodology must be capable of providing updated data on an ongoing basis. Replicable surveys will be cost-effective.

**Projectable** – the survey must provide for statistical projections of future use and demand, based on best estimates using existing records and field counts.

**Samples** – the methodology must, where appropriate, provide useful and valid samples where total user populations cannot be determined for the specific user groups.

**Accessible** – provide the data in an easy to use and read format (as agreed between client and consultant.)

**Spatial** – display, where necessary, the information spatially in terms of location and distribution.

**Digital** – provide numerical, spatial and other information in both raw and processed digital format.

## 6 PROPOSED METHODOLOGY:

To achieve the objectives and data requirements of the TMNP Visitor and User Survey, the following methodological tools could be used:

### 6.1 Visitor and User Field Counts

Field Count of the visitors and user groups identified in the **Scope** (section 3, available as an annex to the ToR), on which statistical projections can be based. Field counts need to determine demographic profiles.

The count should include:

- a) existing records where available (pay points of entry, tourist business records, organisations' records (sports clubs, interest groups), tourist industry statistics
  
- b) field counts of groups and individuals in areas of high, intermediate and low usage, during peak and low seasons

### 6.2 Visitor and User interviews

Short structured questionnaire interviews with visitors and users identified from the TMNP available listings and defined areas. This will include aspects such as, profile, transport, rating of experience, etc.

## **7 DELIVERABLES**

The TMNP visitor and user survey will deliver the following outputs:

- A database (in excel with appropriate and informative meta-data) comprising the following data:

Number and profile of TMNP visitors and users, based on counts, existing records and resulting calculations and projections.

Nature and extent of current usage and activities

Index of visitor / user satisfaction with existing TMNP services and facilities

- Inventory of visitor / user perceived problems and suggestions for improvement
- Ranking of visitor / user needs in order of priority
  
- An estimated eight formal in person presentations / meetings at the Tokai office to TMNP staff and Technical Team for project initiation and project progress reporting
- Three Quarterly Progress Reports (electronic with abridged presentation) to note project status progress and issues to Park Management and Technical Team.
- One on-line presentation to members of the SANParks executive committee and/or the SANParks Board.
  
- Final Report comprising three Volumes (1. Overview and key Results, 2. Technical Report, 3. Key Data summary in the form of Graphs, Visuals Infographics. All three parts of the final report would be in electronic format accompanied by a summary presentation.

## **8 CONSULTANT SKILLS REQUIRED:**

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

**South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.**

- 1.9. **“Delivery ex stock”** means immediate delivery directly from stock actually on hand.
- 1.10. **“Delivery into consignees store or to his site”** means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
