**INTRODUCTION TO SANPARKS**

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

The Parks under the management of SANParks are divided into 6 regions:

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

### **BUSINESS UNIT RESPONSIBLE FOR THE BID**

The Marine Department/Section of the West Coast National Park (WCNP) is situated in Langebaan at the Main Street offices of the West Coast National Park.

This Department is responsible for managing the marine component of the national park, which includes five Marine Protected Areas (MPAs) – Langebaan Lagoon, 16-Mile Beach, Jutten Island, Malgas Island and Marcus Island. The Marine Department supervises the employment of ten staff members, two 4-wheel drive vehicles and a fleet of four boats/vessels.

This section is responsible for all marine matters in the Protected Area – compliance and enforcement, research and monitoring and maintenance of marine and associated infrastructure.

The above results in the regular use of boats/vessels in order to achieve the required territorial integrity of the area. The boats are used on daily basis to (among others) conduct patrols and show presence in the area and conduct trips to the offshore islands to perform research and monitoring functions.

### **CONTEXT OF THIS PROCUREMENT**

Included in the West Coast National Park are the five (5) Marine Protected Areas (Langebaan Lagoon, 16-Mile Beach, Jutten island, Malgas Island and Marcus Island). These MPAs are a national asset and support important marine life. These MPAs are also a source of recreation activities, and limited commercial use. The outcome of this Bid is to ensure that an adequate vessel is provided and available to the marine unit at WCNP to ensure effective management of these MPAs.

In light of the above, SANParks intends to appoint a SERVICE PROVIDER to provide (construct & supply) a Rigid Inflatable Boat (RIB) with trailer to perform various marine tasks in the West Coast National Park.

The successful SERVICE PROVIDER must be an accredited boat builder and be registered as a ISO 9000 Company so as to be able and authorised to construct and supply the specified vessel/boat to the West Coast National Park

### **CONTRACT PERIOD**

It is expected that the successful bidder deliver the boat within 12 months from date of Purchase Order.

## **SPECIFICATIONS/SCOPE OF WORK**

### **DUTIES OF THE SERVICE PROVIDER**

Shall provide the services and goods and deliver the deliverables with skill and care and to the highest professional standard. In compliance with the terms in the specification at all times.

**Any reference to a brand name means equivalent in terms of standard and quality of product.**

### **Provision of a vessel/boat, suitable propulsion system and transport/trailer**

A rigid inflatable boat (RIB) or rigid hull boat, is a lightweight but high-performance and high –capacity boat constructed with a rigid hull bottom joined to side –forming, air tubes that are inflated with air to high pressure so as to give the side’s resilient rigidity along the boat topsides. The design is stable, light, fast and seaworthy. The inflated collar acts as a life jacket, ensuring that the vessel/boat retains its buoyancy, even if the boat/vessel is taking on water. The (RHIB) semi rigid hull boat/vessel is an evolutionary development of the inflatable boat/vessel with a rubberized fabric bottom that is stiffened with flat boards within the collar from the deck or floor of the boat/vessel.

The trailer allows the boat/vessel to transport on land into the water. The boat trailer is subject to the road traffic regulations specific to the payload of the trailer and the towing vehicle. Trailer must be equipped with rollers that make it easier to get in and out of the water.
