- Step 2 Functionality requirements / Technical (Technical will cover this)
- Step 3 Contractual Criteria- Financial Analysis, SHEQ, Environmental and Quality
- Step 4 Contract award
- Step 5- RFQ process



- SHEQ Requirements:
- Quality attached to the tender
- Environmental Attached to the tender
