Please note the following changes on the above-mentioned tender

Below is the initial eligibility criteria that is in the RFP that went to the market:

"Written confirmation from the bidder that all the tyres that will be supplied to TPT will be from the original manufacturer that is registered with the South African Tyre Manufacturers council (SATMC) and/or European Rubber & Tyre Association (ETRMA)

• In case where bidder is OPM

Bidder to submit proof that they are registered with SATMC and/or ETRMA.

In case where bidder is NOT OPM

Bidder to submit the letter from the tyre OPM confirming that they will be supplying them with tyres or confirming they are trading with the bidder, Letter must be submitted on the company letter head. The tyre OPM must ALSO submit proof that they are registered with SATMC and/or ETRMA."

1. Changes in the eligibility criteria

Below is the amended eligibility criteria:

"Written confirmation from the bidder that all the tyres that will be supplied to TPT will be inline with the International Organization for Standardization (ISO).

• In case where bidder is an OPM

Bidder to submit proof from an accredited institution that they are ISO 9001 certified.

• In case where bidder is NOT an OPM

Bidder to submit the letter from the tyre OPM confirming that they will be supplying them with tyres or confirming they are trading with the bidder, Letter must be submitted on the company letter head. The bidder must also submit proof from an accredited institution that the tyre OPM is ISO 9001 Certified."
