Minutes and the presentation would be shared with all bidders in attendance as well as uploaded on the Transnet e-Tenders Management Portal and National Treasury.


Procurement Process

Hlengiwe Zulu outlined the tender process and contents of the RFP. (Refer to the attached briefing session presentation from page 5 to page 16).

The following was highlighted:

- The briefing session is compulsory therefore bidders are to submit their certificate of attendance signed by Employer's representative.
- The submission of the tender is now done online and the instructions on how to submit are on the RFP document.
- It was emphasized that bidders are to submit their tenders at least one day before closing date in order to avoid issues that the bidders may encounter during the closing date and no late tenders will be accepted.

Hlengiwe also explained the Evaluation Methodology that will be used to score the bidders which is based on administrative evaluation, Substantive evaluation, technical evaluation as well as preference points system, and all steps were explained in detail. It was also emphases that bidders that failed to meet pregualification will be disqualified.

Hlengiwe also explained that CIDB grading required for this project is 9EP however the invite was extended to 8EP who are potentially emerging enterprises. It is estimated that tenderers should have a CIDB contractor grading of 9EP. 8EP potentially emerging enterprises who satisfy criteria stated in the Tender Data may submit tender offers. For those bidders that are potentially emerging their CIDB Certificate must indicate that they are potentially emerging.

NEC ECC applicable Clauses - C1.2 Contract Data:



Bidders were also advised to read the NEC clauses and should they have deviations, they must be submitted with the tender.

SD – Transformational objectives

Nandipha Ngcobo from SD section presented SD transformational objectives. She explained that priority will be given to the specific goals to advance areas or categories of persons or groups who were previously disadvantaged. Preferential Procurement point system will be used for this tender is 90/10 where 90 is based on price and 10 is based on the specific goals as follows:

Zukiswa Mpana presented the scope of work explaining project summary, electrical scope of work, control and instrumentation scope of work, building/Civil scope of work, structural scope of work, mechanical scope of work and quality assurance scope of work. If was further explained that some structural works were started and never completed and their the recommended bidder will be to complete that scope of work.

- As part of the Tippler 3 project, new bulk electrical supply infrastructure is to be provided to increase the capacity of the existing power supply to meet current and future demands at the Port of Saldanha.
- The facilities to be provided by the Contractor as part of the works will encompass the following main elements:

New Main Intake Substation, Substation M, and Substation N.
New Eskom 132 kV Control Building and associated high voltage infrastructure.
Protection equipment upgrades and associated works at Eskom's existing Blouwater
and Iscor substations
Installation of new 66 kV circuit breakers, at Eskom's existing Iscor Substation.
Installation of conductors and associated hardware assemblies on the existing Eskom
Blouwater to Iscor /Ystervark 66kV overhead lines.
Provision of new 48 core 16 kA/1s underground optical fibre cable from Blouwater
Substation to Iscor substation/Ystervark substation.
