In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the **CONSTRUCTION OF LEBOHANG STADIUM IN LEANDRA (PHASE 2)**.

Bid documents will be available as from 08h00, 10th April 2024, at the Cash Point by the Cashiers of Secunda offices only, upon payment of a non-refundable deposit of R1000,00. NO EFT.

The closing time for receipt of tenders is **12:00hrs** on **08/05/2024**. Telegraphic, facsimile, e-mail, unmarked and late tenders will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be opened in public.

A non-compulsory briefing session will be held on the 10/04/2024, at 11h00, at the Difa Nksoi Community Hall, Lebohang, Leandra.

Fully completed tender documents, clearly marked Tender No. **8/3/1-6/2024: "CONSTRUCTION OF LEBOHANG STADIUM IN LEANDRA (PHASE 2)"** must be placed in a sealed envelope and placed in the tender box provided by **Govan Mbeki Municipality on the 1st floor, Horwood Street, Secunda, 2302 by no later than 12h00 on 08/05/2023**. The envelope must be endorsed with number, title and closing date as indicated above.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Govan Mbeki Local Municipality where 90 points will be allocated in respective of price and 10 points for a specific goal. Govan Mbeki Municipality Supply Chain Management Policy allocate 10 points in terms of specific goals as follows:

- **Race (HDI) (6)**
- **People with disability (4),**
- **Youth (4)**
- **Woman (4)**
- **Implementing reconstruction and development programe (2).**



No awards will be made to a person:

- Who is not registered on the Central Supplier Database;*
- Who is in the service of the state;*
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or*
- Who is an advisor or consultant contracted with the municipality or municipal entity.*

Bidders that do not hear anything after three (3) months from closing date of this tender must consider their bids as unsuccessful.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

The following documents must be attached (Bidders that fail to submit documents indicated as compulsory will be disqualified)

- **Copy/ printed Tax compliance status Pin to enable the municipality to verify the bidder's tax compliance status- Compulsory**
- **Copy of bidder's or director's current municipal account (not older than 3 months) or copy of valid Lease Agreement – Compulsory**
- **Valid CSD summary report – Compulsory**
- **Audited annual financial statements for the past 3 years for Bid above R10m. for companies required by law to submit annual financial statements - Compulsory.**
- **Valid CIDB Certificate 6CE or Higher**
