Laying of uPVC bulk pipelines from boreholes to storage tanks, laying reticulation line of HDPE pipes, yard connections, equip and electrification of new and existing boreholes, Refurbishment of existing boreholes, supply and Installation of four elevated steel tanks; yard connections and Assembling four Chlorination Plants.
