### 1 Responses to RFQ

In the interest of fairness and transparency Transnet's response to such a query will then be made available to other bidders.

2.2 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFQ between the closing date and the date of the award of the business.

2.3 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

2.5 All unsuccessful bidders have a right to request Transnet to furnish individual reasons for their bid not being successful. This requested must be directed to the contact person stated in the SBD 1 form

### 3 Legal Compliance

The successful Respondent shall be in full and complete compliance with any and all applicable national and local laws and regulations.

### 4 Employment Equity Act

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

### 5 Changes to Quotations

Changes by the Respondent to its submission will not be considered after the closing date and time.

### 6 Binding Offer

Any Quotation furnished pursuant to this Request shall be deemed to be an offer. Any exceptions to this statement must be clearly and specifically indicated.

### 7 Disclaimers

7.1 Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFQ and/or its receipt of a Quotation in response to it. Please note that Transnet reserves the right to:

- modify the RFQ's goods / service(s) and request Respondents to re-bid on any changes;
- reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- disqualify Quotations submitted after the stated submission deadline;
- not necessarily accept the lowest priced Quotation or an alternative bid;
- place an order in connection with this Quotation at any time after the RFQ's closing date;
- award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;

- split the award of the order/s between more than one Supplier/Service Provider should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- cancel the quotation process;
- validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;
- request audited financial statements or other documentation for the purposes of a due diligence exercise;
- not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provides for it;

## **8 Specification/Scope of work**

Transnet seeks to appoint a competent and experienced Service Provider for the provision of personal protection services (Close Armed Protection Services) for a period of two (2) years on an as and when required. Bidders must demonstrate their capabilities and qualifications in rendering and offering the required services as per the scope of work. The appointed service provider must be responsible to provide up to six (6) Close Armed Protectors as and when required by Transnet. Close Armed Protection service must be provided to Transnet Employees based on the recommendation of a threat and risk assessment report or an interim approval of the Board. The service providers must be responsible for the transportation of the Principal to and from Transnet Principal specified location/premises. The Close Armed Protector must be responsible to transport the Principal's home and to the office and perform escort duties. The aim of a protection services is to preserve the life of the person being protected (Principal) and prevent or minimize the effect of an attack intended to cause physical harm or embarrassment.

### **8.1 The project scope is likely to include, inter alia, some or all of the following dependent on nature of the case required:**

- ❖ Up to Six (6 x Close Armed Protectors with Grade C and Close Armed Protection Qualification) to be available as an when required.

- ❖ The service provider must provide high performing SUV vehicles with 130kw engines and upwards, that are in good working condition to transport the Principal's between home and office and as per any other assignment. Please be advised that the **Toyota Fortuner** is not accepted.
- ❖ Vehicle checklist will necessary both before and after being left standing by itself.
- ❖ Maintenance / service & repair of the service provider's vehicles will be for its own account. Transnet shall not be liable to the service provider for the cost of any maintenance/service and/or repairs of its vehicles.
- ❖ After-market vehicle conversions will not be acceptable for this service.
- ❖ Licensed and Roadworthy: Certified and valid copies of vehicle licenses and roadworthy certificates.
- ❖ The Close Armed Protectors should always be armed all the time. Below is a list of firearms that are acceptable:
  - 1) **Handguns:**
    - CZ75 P-07
    - Glock 9x19 Generation 5
  - 2) **Shotguns:**
    - Mossberg 590A.
  - 3) **Rifles:**
    - CZ Scorpion.
    - Carbine LM 5.56
    - An alternative rifle to the ones recommended will require approval by the Group Security Governance Committee in instances where there is no availability of supply or non-responsive bids.

## 8.2 Safety Clothing /Uniform and Equipment

- ❖ Dress Code formally and depending on the event.
- ❖ All the time Bulletproof/Vest must be worn
- ❖ All the time the Vests must be worn
- ❖ Reflector jackets
- ❖ Handcuffs
- ❖ Pepper Spray

## 8.3 Close Protection Requirement

- ❖ Close protection operations – planning, operational and post deployment.
- ❖ Security chauffeur – safe and reliable transportation of individuals and assets, dealing and responding to perceived threats, qualified in safe driving.
- ❖ Planning and execution
- ❖ Reassurance and protection for the safety of clients.
- ❖ Secure journey management – professional escorting of clients safely and securely on journeys from home to destination.
- ❖ Protection of persons at official gatherings.
- ❖ Observe Personal threat and risk on daily basis.
- ❖ Surveillance awareness.
- ❖ Conduct reconnaissance.

#### **8.4 The Responsibility of the Service Provider**

- ❖ Service provider to provide close armed protectors to travel and sleepover in the province /other province/or other areas as when Required. Transnet will bear the Travel arrangement cost.
- ❖ Service provider expected to cater for enough physical close armed protectors and relievers in the plan. The relievers must meet the criterion same as the close armed protector.
- ❖ Service provider required to supervise and exercise proper control over its personnel and shall not hold Transnet liable for any loss or injury caused to the said personnel.
- ❖ Service provider required to seek to resolve any problems relating to its personnel in line with the laws of the country (e.g. Labour Laws);
- ❖ Service provider required to maintain a logbook of kilometers travelled and trips must be approved by the Transnet. The distance travelled must be recorded from the pickup point of the subject to the drop-off point.
- ❖ Strike Contingency Plan, mitigation of all risk associated with security service, Contingency Labour work and the strike management plan.

#### **8.5 Required Competencies of the Protectors are as follows:**

- ❖ Respond to trauma and medical crisis (First Aid Certificate Level 2)
- ❖ Advanced driving skills with relevant courses to support.
- ❖ Grade 12 (National senior certificate)
- ❖ Grade C (PSRA certificate)
- ❖ A relevant and valid firearm competency certificate issued by SAPS
- ❖ Valid driver's license 4
- ❖ Close Armed Protectors must be South African and with no dual Citizenship.
- ❖ No criminal Record.

#### **8.6 Close Armed Protector Operation Management Excellence**

- ❖ All shifts are as and when required.
- ❖ The close protector service may on occasion be required to work after hours/Saturdays/Sunday/Public Holidays.
- ❖ All incidents must record in the pocketbook daily.

#### **8.7 Location of Services**

- ❖ The close protectors will be commuting in between Principal premises to Transnet office, provincial offices, and anywhere else where the Principal's are required in terms of their work obligations and personal obligations where necessary.

#### **8.8 Expected Outcomes and Deliverables**

- ❖ Submit monthly security reports to the Transnet a project manager detailing threats, challenges, and successes whilst rendering the services for each project.
- ❖ The project is on an "as-and-when required" and appointment periods may vary depending on the duration of the case.



- ❖ The expected outcomes and deliverables will be determined on a project-by-project basis based on the needs.

## 8.9 Company Liability Insurance

- ❖ The service provider(s) must on an appointment, take out insurance against claims, costs, loss of life, injury to the third party, and/or damage to movable or immovable property ensuring their obligations and shall ensure that such insurance remains operative for the duration of this agreement. The minimum amount of R5 million per service provider.
- ❖ Neither Party excludes or limits liability to the other Party for: death or personal injury due to negligence; or fraud.
- ❖ The Service Provider shall indemnify and keep Transnet indemnified from and against liability for damage to any Transnet property [whether tangible or intangible] or any other loss, costs or damage suffered by Transnet to the extent that it results from any act of or omission by the Service Provider or its Personnel in connection with this Agreement.
- ❖ Transnet shall indemnify and keep the Service Provider indemnified from and against liability for damage to the Service Provider's property [whether tangible or intangible] or any other loss, costs or damage suffered by the Service Provider to the extent that it results from any act of or omission by Transnet or its Personnel in connection with this Agreement.
- ❖ Subject to clause 1.1 above, and except as provided in clauses 1.2 and 1.3 above, in no event shall either Party be liable to the other for indirect or consequential loss or damage or including indirect or consequential loss of profits, business, revenue, goodwill, or anticipated savings of an indirect nature.
- ❖ If for any reason the exclusion of liability in clause 1.4 above is void or unenforceable, either Party's liability for all loss or damage under this Agreement shall be as provided in clauses 1.2 and 1.3 above.
- ❖ Nothing in this clause 1 shall be taken as limiting the liability of the Service Provider in respect of clause *[Intellectual Property Rights]* or clause *[Confidentiality]*.

## 8.10 Indemnity Insurance

- ❖ Without limiting the liability of the Service Provider under this Agreement, the Service Provider shall take out insurance in respect of all risks for which it is prudent for the Service Provider to insure against, including any liability it may have as a result of its activities under this Agreement for theft, destruction, death or injury to any person and damage to property. The level of insurance will be kept under review by Transnet, to ensure its adequacy, provided that any variation to the level of such insurance shall be entirely at the discretion of the Service Provider.
- ❖ The Service Provider shall arrange insurance with reputable insurers and will produce to Transnet, on request, evidence of the existence of the policies.  
Transnet reserves its right to proceed against the Service Provider in respect of any claims for loss or damages of whatsoever nature arising from the performance by the Service Provider of its obligations under this Agreement, whether or not such events which give rise to the occurrence of loss or damages are insured by the Service Provider or are in excess of the Service Provider's insurable limits.

## 9 Legal review

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business.

**10 Security clearance**

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the goods and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of CONFIDENTIAL/ SECRET/TOP SECRET. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

**11 National Treasury’s Central Supplier Database**

Respondents are required to self-register on National Treasury’s Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Transnet is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. Business may not be awarded to a respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD. The CSD can be accessed at <https://secure.csd.gov.za/>.

**For this purpose, the attached SBD 1 Form must be completed and submitted as a mandatory returnable document by the closing date and time of the bid.**

**12 Tax Compliance**

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).


It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.

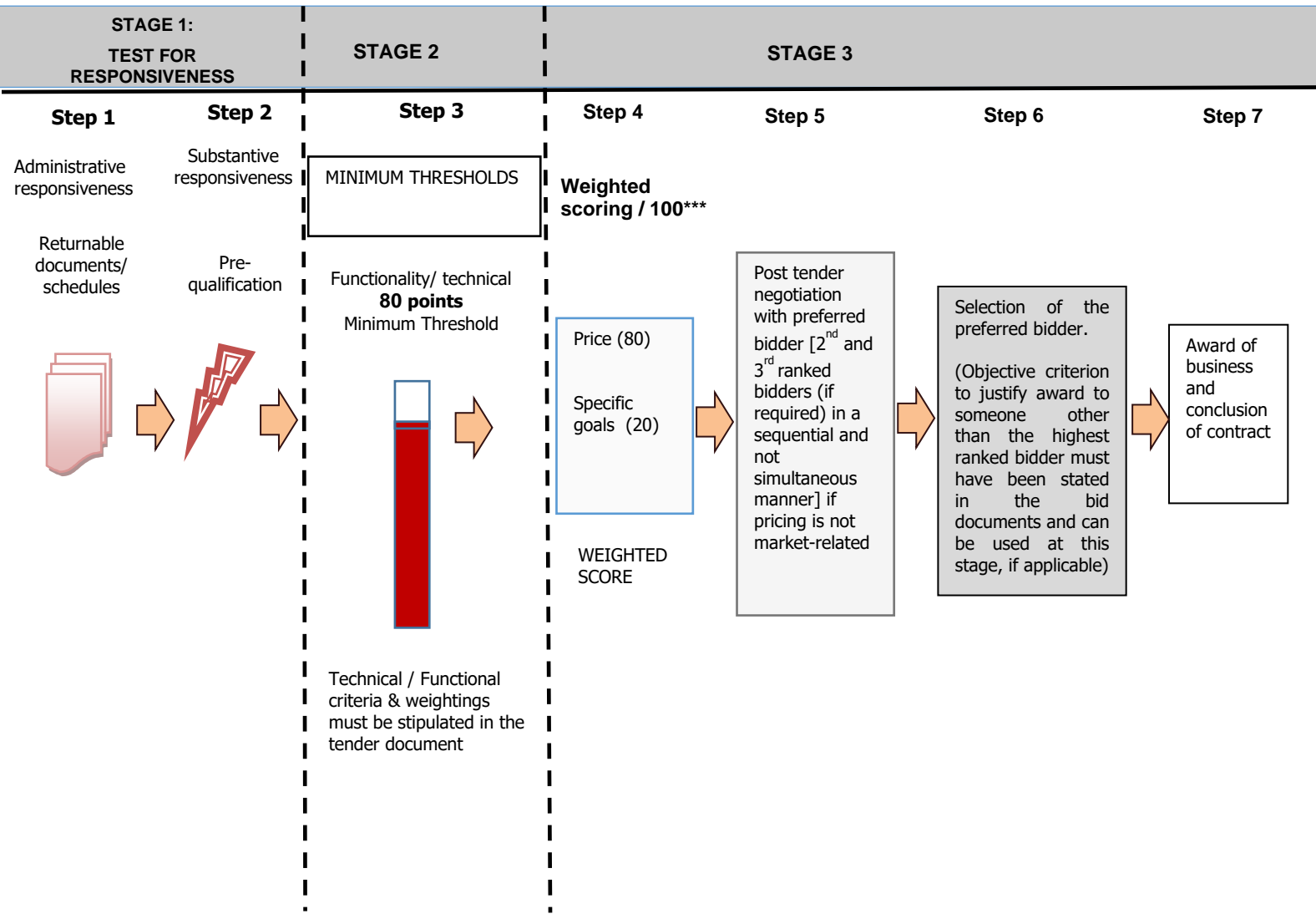

### SECTION 3

## EVALUATION METHODOLOGY, CRITERIA AND RETURNABLE DOCUMENTS

### 1 Evaluation Criteria

Transnet will utilise the following methodology and criteria in selecting a preferred Supplier/Service provider:



#### 1.1 STEP ONE: Test for Administrative Responsiveness

The test for administrative responsiveness will include the following:

- (e) **"Broad-Based Black Economic Empowerment Act"** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (f) **"EME"** means an Exempted Micro Enterprise as defines by Codes of Good Practice under section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (g) **"functionality"** means the ability of a bidder to provide goods or services in accordance with specification as set out in the bid documents;
- (h) **"Price"** includes all applicable taxes less all unconditional discounts.
- (i) **"Proof of B-BBEE Status Level of Contributor"** means:
- 1) B-BBEE status level certificate issued by an unauthorised body or person;
  - 2) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
  - 3) Any other requirement prescribed in terms of the B-BBEE Act.
- (j) **"QSE"** means a Qualifying Small Enterprise in terms of a Codes of Good Practice under section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 ( Act No. 53 of 2003);
- (k) **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties.
- (l) **"Specific goals"** means targeted advancement areas or categories of persons or groups either previously disadvantaged or falling within the scope of the Reconstruction and Development Programme identified by Transnet to be given preference in allocation of procurement contracts in line with section 2(1) of the PPPFA.

## 3. POINTS AWARDED FOR PRICE

### 3.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

4.4 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.

4.5 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.

4.6 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
