### **PURCHASE, COLLECT AND REMOVE USED TURBINE LUBE ( Castro- THZ32 lube oil) PLUS OR MINUS 30 000 LT LOCATED AT DUVHA POWER STATION**

The purchaser must assure the site be left clean at completion of their collection and removal of the goods.

Purchase and removal of turbine oil ( Castro- THZ32 lube oil) plus or minus 30 000 LT that has been spilled to the station drains at Duvha Power Station and currently contained in the ash sump.

The oil is stored in tanker tanks and 210L drums. Collection for the oil is at Duvha Power Station. turbine oil ( Castro- THZ32 lube oil) that is mixed with water and currently contained in the ash sump. The purchaser will be responsible for the safe collection, handling, removal, and transportation of the used transformer oil as well as to clean the site, qualified labour and suitable certified plant, machinery, equipment and transport for this purpose.

Payment shall be made to Eskom no later than five days after the date of the sale. The release of the equipment/scrap to the new buyer will take place after receipt of payment to Eskom and the buyer acquiring a permit to remove and transport the equipment/scrap.
