2. OBJECTIVE

It is against this background that the municipality seeks to provide a safe and attractive environment for its cemeteries, clients, and councillors of the IHLM. This can be done through many things, such as, grass cutting activities by internal staff or outsourcing of these services when there are unforeseen challenges internally.

3. SCOPE OF PRACTISE

To provide grass cutting activities for Two (2) Municipal Cemeteries and One (1) Sport Field namely:

- > Lusikisiki Cemetory with 4 461 Square meter.
- Flagstaff Cemetory with 3 730 Square meter.

 - i) The information furnished is true and correct;
