The scope of work will include the purchase, collection and removal of SCRAP USED OIL on a "ONCE OFF BASIS" required basis contract within Eskom HENDRINA POWER STATION. THE OIL TYPES COULD BE A MIXURE OF TRANSFORMER OIL, BREAKER OIL, INSULATION OIL AND OR HYDRAULIC OIL. THIS OIL IS DEEMED SCRAP AS THE PCB LEVEL IS BELOW 50 PPM AND MAYBE CONTAMINATED WITH WATER AND DUST OR SAND. THE REQUIREMENT IS TO SERVICE ESKOM HENDRINA POWER STATION ON A ONCE OFF BASIS TO REMOVE THE OIL FROM JOJO TANKS, OR DRUMS. YOU WILL HAVE TO ALSO REMOVE AND DISPOSE OF THE DRUMS IF THE OIL IS STORED IN DRUMS.
