- 1 Quotation documents must be completed in black ink.
- 2 The lowest price or any quotation will not necessarily be accepted, and the City of Johannesburg reserves the right to accept the whole or any portion of a quotation.
- 3 Quotations are to remain open for acceptance for a period of thirty (30) days effective from the date on which they are lodged and shall be accepted at any time within the said period of thirty (30) days.
- 4 Tenderers are requested to furnish the full registered name of the tendering company/supplier on the Form of Quotation and Form of Acceptance, Form B.
- 5 Tenderers are also required to sign each page of the Form of Quotation and Form of Acceptance, Form B, in the space provided at the bottom of each page.
- 6 **In the event of a mistake having been made on the price schedule it shall be crossed out in ink and be accompanied by an initial at each and every price alteration. **DESCRIPTION: TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER TO PROVIDE AUDIT RELATED SERVICES FOR THE UNITED NATIONS ENVIRONMENTAL PROGRAMME FUND (GEF GRANT FUNDING)**

**SPECIFICATION**

**BACKGROUND**

City of Johannesburg Metropolitan Municipality (herein referred to as “City/CoJ”) is committed to deliver on its international commitments regarding climate change declarations. CoJ has accepted the Global Environmental Facility (GEF) grant funding for the implementation of a project titled “**BUILDING A RESILIENT AND RESOURCE EFFICIENT JOHANNESBURG, INCREASED ACCESS TO URBAN SERVICES AND IMPROVED QUALITY OF LIFE**” in partnership with United Nations Environmental Programme (UNEP) and the Development Bank of Southern Africa (DBSA).

The primary objective of GEF project is to reduce the carbon footprint of the City and to allow for better adaptation to the changing climatic conditions that the City is facing, to encourage city-level resilience, resource efficiency and emission reductions through area-based pilot demonstrations.

The outcomes of the GEF project are as follows:

- *Outcome 1:* City of Joburg Municipality test Eco district prototypes to set improved environmental standards for Corridors of Freedom (Development Planning)
- *Outcome 2:* City of Joburg Municipality adopts gender sensitive and resource efficiency guidelines for improved sustainability of social housing (JOSHCO)
- *Outcome 3:* Emerging urban farmers increasingly implement more environmentally sustainable food security solutions (Social Development)
- *Outcome 4:* City of Joburg Municipality adopts an integrated biodegradable waste management strategy and has pre-investment documents to mobilize finance to implement the strategy (EISD and DBSA)
- *Outcome 5:* Enhanced capability of City of Joburg Municipality in evidence-based policy and strategy making (Development Planning)

The duly signed Project Cooperation Agreement (PCA) that CoJ has entered into with the project partners, requires that the project’s expenditures and accounts for each calendar year need to be audited by an independent audit authority on an annual basis (clauses 36 and 37 of the PCA). It specifically requires that all financial reporting in the audit report shall be in US dollars and the local currency.

As such, all project expenditures incurred between 1 January 2023 to 31 December 2023 for the GEF grant (all components) will need to be audited by a recognized firm of certified public accounts contracted by the City, and the audit report shall be submitted to UNEP a month after the appointment of a service provider.

**3. SCOPE OF WORK**

The audit report and recommendations shall include such comments as the auditor may deem appropriate in respect of GEF funded operations and in particular, shall clearly indicate that in **their opinion:**

- a) GEF funds were covered by the scope of the audit.
- b) Proper books of account have been maintained.
- c) All project expenditures are supported by vouchers and adequate documentation.
- d) Expenditures have been incurred in accordance with the objectives outlined in the CEO Endorsement Document.
- e) The expenditure reports provide a true and fair view of the financial condition and performance of the project.

f) The service provider shall submit three (3) audited financial reports: i) for the UNEP's share of the grant (components 1,2,3 and 5); ii) for the DBSA share of the grant (component 4) and iii) a consolidated project audited financial report inclusive of both UNEP and DBSA (components 1,2,3,4 and 5). All financial reporting in the audit report shall be in US dollars and the local currency (Rand).

The UNEP portion of the grant expenditure incurred by the City of Johannesburg (components 1,2,3 and 5) from the 1 January 2023 to 31 December 2023 was to the total amount of **US\$ 302,511**, with 29 invoices settled during the period.

There were 11 financial transactions processed by the DBSA during the period.

#### **4. WORK PLAN AND SCHEDULING**

To carry out twelve months' grant financial statement audit, the following work will need to be undertaken by the appointed service provider:

- Agree and sign a letter of engagement for the conduct of the audit.
- Agree to a timetable for performance of the audit. This should allow adequate time for planning, on-site work, follow up work and questions, and reporting.
- Ensure that qualified and experienced staff is available for the duration of the audit.
- Agree and adhere to a price for the audit.
- Agree to the transaction samples in advance.
- Carry out the on-site work as planned and agreed.
- Hold an exit meeting at the end of the on-site audit work.
- Carry out follow up work including the exchange of drafts for commentary and feedback.
- The audit will be performed in office of the CoJ and may also involve some audit work to be carried out in other regions and field offices within the City.
- Finalisation of the report within 30 days of appointment.

#### **5. INTELLECTUAL PROPERTY RIGHTS**

All copy rights and intellectual property rights that may result as the consequences of the work to be performed will become the property of City of Johannesburg.

#### **6. PRICING AND PROPOSAL SUBMISSION**

It is critical to note that at the core of this RFQ lies quality and cost effectiveness in the delivery of services. Bidders are therefore required to be mindful of their business models in relation to costing of their offers and successful bidders will be expected to negotiate terms and conditions with the strategic partners.

In as far as possible, bidders are expected to therefore demonstrate proof of any business relations and alliances that will give the City comfort that the required services will be delivered up to the required service levels within expected turnaround times.

The City pays service providers on presentation of invoices at the successful completion of deliverables. Successful service providers are therefore not expected to make requests for any upfront payments.

Stage 1: Functionality, and

Stage 2: Pricing and BBBEE preferential procurement criteria.

The evaluation of bids shall be based firstly on FUNCTIONALITY criteria in *Table 1*. Only those bidders that meet the minimum threshold of **75 points** shall be considered for the subsequent stages of the evaluation process. A bid that scores less than 75 points for FUNCTIONALITY shall be regarded as non-responsive and shall not be considered for further evaluation.

  - (e) forward the matter for criminal prosecution, if deemed necessary.
