1. BACKGROUND

The existing application software is a modular all-encompassing Fresh Produce Market and Agency Management System. The system comprises some 2200 programs and procedures and updates in excess of 250 database files/tables. The real time Market Trading System is a critical system for the daily functioning of the market.

The market's sales hours are from 05:00 to 10:30 and an average of 13 636 sales transactions are processed daily with an average turnover of R13m per day. All clearances, payments, pay-outs, reports and statistics are done on the system in the interest of producers, agents, buyers and market management.

Transactions to purchase produce on the Tshwane Market can only take place if a buyer has a valid buyer's magnetic tag and an account with the market. The buyer's magnetic tag is swiped through a dual frequency programmable magnetic tag reader which is connected to a dumb terminal to initiate the processing of a sale once an agreement is reached between the buyer and agent regarding the amount and price.

The dumb terminal forms an integral part of the buying system used. A continuous, reliable supply of a good quality, durable dumb terminal is therefore required to deliver an uninterrupted service to buyers and other role players on the market.

2. SCOPE OF THE CONTRACT

2.1 DUMB TERMINAL

Dumb Terminal is a fan-less design, quiet and low power consumption small-size computer. A dumb terminal is a monitor that does not operate on its own and depends on a host computer for processing. This type of terminal has limited features and little to no processing power. It acts as an input/output device when connected directly to a processor or through a network.

2.3 COMPATIBILITY

The required product must be fully compatible with:

- e) The Redhat Linux Enterprise Operating System

2.4 DELIVERY PERIOD

- a) The service provider must be able to deliver dumb terminals within two (2) weeks after a purchase order has been issued.
- b) The service provider must further keep a sufficient quantity of dumb terminal in stock, as agreed with the market, to prevent any possible delays in the supply thereof.

3. WARRANTY

- a) The service provider must warrant that the dumb terminals supplied in this contract are new, unused and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract.
- b) The service provider must further warrants that all dumb terminals supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- c) This warranty shall remain valid for the duration of use of the specific batch delivered by the supplier to the market.
- d) Should any defect in a single batch be detected by the market, the service provider must replace the total batch within seven (7) days.
- e) If the supplier, having been notified, fails to remedy the defect(s)/ replace the batch delivered within the seven (7) day period, the market may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

4. PACKING

- a) The supplier shall provide such packing as is required to prevent damage or deterioration of the dumb terminal during transit to or during storage at the market facility.
- b) The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage.

6.2 MANDATORY REQUIREMENTS

The offer and technical data/brochures must correspond with the description of all specifications of the equipment. If the Service Provider is not a manufacturer, they should attach that of the manufacturer.

6.3 PREFERRENCE POINT STSTEM

9. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct a market analysis. Should the City exercise this option, where a tenderer offers a price that is deemed not to be viable to the services as required, written

confirmation will be made with the tenderer if they will be able to deliver on the price determined by the City. If a tenderer confirms that they cannot, the tenderer will be disqualified based on being non-responsive.

If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract, including performance warnings, and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market-related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the second-highest points. If the tenderer scoring the second-highest points does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the third-highest points. If a market-related price is not agreed upon, the City reserves the right to cancel the quotation.
