1. PURPOSE

The purpose of this exercise is to appoint of a service provider to supply 18 x desktop towers + 21" screens for the Skukuza Safari Lodge Admin Block.

2. BACKGROUND

Skukuza Management services is a private entity appointed by SANParks to manage Skukuza Safari Lodge under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

Skukuza Management Services operations are totally guided by its vision statement and mission statement. As a private entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

The Service Provider will be required to supply:
