INTRODUCTION:

The Market Theatre Foundation (MTF) is a Schedule 3A Public Entity in terms of the Public Finance Management Act (PFMA). The MTF is governed by the Cultural Institutions Act, as amended by the Cultural Law as Amendment Act (No 36 of 2001), and is an agency of the Department of Sport, Arts and Culture.

PURPOSE:

The purpose of this RFQ is to seek the services of an accounting or audit firm to assist with the financial year processes and preparation of the Annual Financial Statements.

REQUIREMENTS OF SERVICE PROVIDER:

- SAICA or SAIGA qualification
- CV of personnel with a minimum of 8 years public sector finance experience with at least 3 years at Finance Manager level.
- Personnel must have working knowledge of CaseWare and preparation of GRAP financial statements.
- Prospective Service Provider must provide personnel that demonstrates specific experience in providing the skills required by MTF with regards to AFS preparation for their quotations to be considered.
- Prospective Service Provider must demonstrate that they have a proven track record in compiling AFS for public entities by providing at least two reference letters to substantiate experience for their quotations to be considered.
- A company profile including CV of the employee delegated by the Prospective Service Provider to prepare draft AFS accompanied by proof of relevant qualifications BCom (Accounting) or equivalent NQF Level 7) and a reference or support letter indicating that the consultant has a proven record of working with CaseWare Software/ Systems for their quotations to be considered.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **"tender"** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "**price**" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **"tender for income-generating contracts**" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "**the Act**" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—


