TENDER 7/2024 – BAVIAANS RIVER PHASE 2: CONSTRUCTION OF EROSION PROTECTION STRUCTURES IN BAVIAANS RIVER, GENADENDAL: GR 30 to GR 40

The works, as described, is part of the Disaster Management Programme for the Baviaans River situated next to Genadendal, Western Cape. The bid will be a measured bid for the works described and is to include material, labour and machinery. The works must be completed within a **6-month** (definition as defined further) contract period.

The scope of works entails **the construction of 11 (eleven) gabion structures (groynes)** in the Baviaans River over an approximate **distance of 1 km** as well as rehabilitation work to Groynes 1 to 29 which was damaged by past floods.

Bidders must have a CIDB contractor grading designation of **6 CE** or higher.

There will be a **compulsory site meeting**. The meeting will be held at the **Genadendal Werf** (opposite the Genadendal museum) situated in Moravia Street (GPS Co-ordinates: 34° 21.96"S, 19°33'27.41"E) on **8th May 2024 at 11:00**. Notice of attendance to be given no later than 12:00 on 6th May 2024.

Please take note that bidders not attending the compulsory site meeting will not be eligible to submit a bid. A locality map (pdf format) with directions to the site is available on request.

BID DEADLINE: The closing date for the bid is 17th May 2024 strictly at 12H00.

Proposals must be submitted in a sealed envelope marked as "**BID NO 7/2024 – BAVIAANS RIVER PHASE 2**" and placed in the tender box available at Reception, Casidra's Head Office, 22 Louws Avenue, Southern Paarl. No faxed, counter-to-counter courier or posted bids will be accepted.
