## 1 Description of the works

### 1.1 Executive overview

The works entails the replacement of the aluminium framed doors with aluminium sliding door and aluminium framed glass windows.

## **Summary of the major tasks include:**

- Removal of the existing 2x aluminium framed glass doors.
- Installation of 1x aluminium framed fixed-pane window.
- Installation of 1x aluminium framed sliding door.

### 1.2 Location of Works

The work is located at Port Control Building, Port Manager's Office in the Port of East London. The area is access controlled and all security and safety protocols must be adhered to.

## 2 Employer's objectives

## Background

The port manager's office is facing problems with worn-out and corroded hinges on its aluminium doors, which raises safety concerns because one door also falls unexpectedly when opened due to wind. The compromised doors pose safety risks to individuals accessing the office.

It has become necessary to replace the aluminium doors to ensure that the office premises run smoothly and securely, the replacement doors will prioritize durability, safety features, functional design, security, and compliance with applicable requirements.

## 3 STANDARDS AND SPECIFICATIONS

All work shall conform to all applicable standards and regulations. The contractor shall be aware of the following standards that he/she should adhere to:

## 3.1 Standards Adherence

- Occupational Health and Safety, Act 85 of 1993.
- SANS 10400A, National Building Regulations, Act 103 of 1977.
- Construction Regulations, 2014.

## 3.2 Specification

### **Fixed Pane Windows**

- The fixed pane window shall be aluminium framed. The colour of the frame shall be

## 4 General Requirements

- The contractor is to remove and appropriately dispose offsite all waste.
- The Contractor is liable for any damage or loss of equipment immediately after they
  have been granted site access to resume the work.
- The flow diagram of the process shall be supplied to National Ports Authority prior to any work being carried out
- The contractor shall provide ongoing site cleaning as required on a daily basis to the satisfaction of the TNPA supervisor.
- The Contractor shall comply with Transnet's safety requirements.
- Attendance to the site briefing is compulsory.

## 5 COMPLETION OF THE WORK

- Take-over will take place when commissioning is completed. Outstanding items on the snags list will be attended to by the Contractor.
- Invoicing will be done once all the works is certified complete.

## 6 HEALTH AND SAFETY REQUIREMENTS
