Tenderers are to note the following amendment to the tender documentation, which shall be deemed to be necessary changes to the tender documentation in this regard. All other tender documentation remains unchanged.

ADDENDUM NO.1

Addendum No. 1 incorporates the following changes:

1. CHANGE TO T2.2-06: HEALTH AND SAFETY REQUIREMENTS

Bidders attention is drawn to **page 38 and 40** of the RFP document under **T2.2-06: Health and Safety Requirements**, where the total evaluation points for this element is erroneously reflected as **10 points**. Whereas, it was supposed to be reflected as **15 points**.

Change made:

Changed the **Health and Safety Requirement** evaluation points from **10 points** to **15 points**.

2. CHANGE TO C2 PRICING DATA

Bidders are to note the C2 pricing data.

The construction period is 15 months

Changes made include:

The construction period is confirmed at 12 months. The BOQ has been revised to state 12 months for the contract period.

3. PORT ENTRY PERMIT APPLICATION FORMS INCLUDED AS ANNEXURE

Bidders are to note the Port Entry permits application forms.

Changes made include:

The Port Entry permits application forms has been included on the amended tender document, in response to question by tenderer.

4. CHANGE ON CLOSING DATE AND SITE VISIT DATE

On page 4 of the RFP document, the Site Visit was scheduled on the 16th April 2024, however at the Compulsory Briefing Meeting, bidders were informed of the postponement of the Site Visit to a later date still to be confirmed. The Non-compulsory Site Visit will now be held on **29 April 2024**

@10h00 and the meeting place is Transnet Maritime Training Centre, Corner Coode Crescent and Duncan Road, Cape Town (opposite the Police Station).

The change in the Site Visit date necessitated the extension of the closing date from 6 May 2024 at 16h00 to **20 May 2024 @ 16h00**.

The clarification closing date: **10th May 2024 @ 16h00**

The Non-compulsory site visit date: **29th April 2024 @ 10h00, meeting place:** Transnet Maritime Training Centre corner of Coode Crescent and Duncan Road, Cape Town.
