Bidders are to note the following amendment to the tender documentation, which shall be deemed to be necessary changes to the tender documentation in this regard. All other tender documentation remains unchanged.

BRIEFING NOTE NO.2

Briefing Note No. 2 incorporates the following changes:

1. Change no.1

Tenderers are to note the following the briefing session venue has been changed due to logistical reasons from TNPA House 10 Floor Boardroom to TNPA Maritime Training Centre (red house opposite SAPS Police Station), corner of Coode Crescent and Duncan Road.

2. Change no. 2- Clause 43.1

The Bidder is required to note the changes in clause 43.1 of the RFP which reads as follows:

43.1 A compulsory briefing to Bidders will be held physically in respect of the Project, during which time the approach to the Project will be outlined and where key issues of concern or matters requiring clarification are to be raised.

Changes to the clause are as follows:

Bidders who are not able to make it to the site will be given the option to attend online, they need to send an email request to Poctliquidbulkrfp@transnet.net for the Teams link to join the session by not later than 6th of May 2024.

Bidders must note that it is for their benefit to attend the site visit however failure to visit the site will not result in disqualification.

The briefing session is compulsory.



3. Site Visit Requirements

A site visit/walk will take place, Bidders are to note:

- Bidders are required to wear safety shoes, high-visibility vests, and hard hats.
- All forms of firearms are prohibited on Transnet properties and premises.
- The relevant persons attending the meeting must ensure that their identity documents/passports or driver's licenses are on them for inspection at the access control gates.
- Bidders without the recommended PPE will not be allowed on the site walk.

NOTE WELL: Bidders are to note that they should use the above information for this RFP.

All other terms and conditions of the bid documents remain unchanged.
