THE NAME AND ADDRESS OF THE BIDDING COMPANY MUST BE ENDORSED AT THE BACK OF THE ENVELOPE.

Bid offers must be deposited in the Bid Box at the office of the Agribusiness Development Agency (ADA), 5 Cascades Crescent, Cascades Office Park, Montrose, and Pietermaritzburg before the closing date and time, 05 June 2024 at 11:00am. Bid offers will be opened immediately thereafter.
