- 1.12 The South African Weather Service shall on receipt of any proposal relating to this bid become the owner thereof and shall not be obliged to return any proposal.
- 1.13 The bidders shall indemnify the South African Weather Service against all third-party claims of infringement of patent, trademark, or industrial design rights arising from the use of the goods or any part thereof by the South African Weather Service.
- 1.14 The South African Weather Service reserves the right to request a bidders latest audited financial statements prior to the award of the bid in order to ascertain financial stability of the bidder. Failure by a bidder to provide such information upon request may result in the rejection of the bid submitted by the bidder.
- 1.15 Subcontracting: Tenderers or contractors must submit proof of subcontracting between the main tenderer and the subcontractor. Proof of subcontracting arrangement may include a subcontracting agreement between the main tenderer and the subcontractor.
- 1.16 The SAWS reserves the right to request final presentation only to the short listed bidders to the evaluation committee. The shortlisted service providers will be subjected to present their service offering in line with the bid requirements/scope of work. The SAWS might also conduct site visit to ensure the firm existence and validate the firm's proposed capacity/employees and administration office.
- 1.17 The service provider must have duly approved operational premises with the necessary infrastructure to provide services and relevant accreditation by the relevant body. Before the awarding of the tender a due diligence site visit will be carried out at the premises of the service provider.
- 1.18 Supplier Performance Management is viewed by the SAWS as critical component in ensuring value for money acquisition and good supplier relations between the SAWS and all its suppliers. The successful bidders shall upon receipt of written notification of an award, be required to conclude a SLA with the SAWS, which will form an integral part of the supply agreement. The SLA will serve as a tool to measure, monitor and assess the supplier's performance level and ensure effective delivery of service, quality and value-add to SAWS's business. Successful bidders are required to comply with the above condition, and also provide a scorecard on how their product / service offering is being measured to achieve the objectives of this condition.
- 1.19 The SAWS respects your privacy and acknowledge that your submission/s will contain personal details, which may belong to you, others and / or to your company (Personal Information). Bid, all payments due to creditors for goods delivered / services rendered will be settled within thirty (30) days from receipt of an invoice.

2. TAX COMPLIANCE REQUIREMENTS

- 2.1 Bidders must ensure compliance with their tax obligations.
- 2.2 Bidders are required to submit their unique Personal Identification Number (PIN) issued by the South African Revenue Service (SARS) to enable the South African Weather Service to verify the taxpayer's (Bidder's) profile and tax status.
- 2.3 Application for a Tax Compliance Status (TCS) Pin may be made via e-filing through the SARS website www.sars.gov.za
- 2.4 Bidders may also submit a printed Tax Compliance Status (TCS) certificate together with the bid.
- 2.5 In bids where consortia / joint ventures / sub-contractors are involved **each** party must submit a separate TCS certificate / Pin / CSD number.
- 2.6 Where no TCS Pin is available but the bidder is registered on the Central Supplier Database (CSD), a CSD number must be provided.
- 2.7 No bids will be considered from persons in the service of the state, companies with directors who are persons in the service of the state, or close corporations with members persons in the service of the state.
- 2.8 Foreign suppliers with neither South African tax obligations nor history of doing business in South Africa must complete the questionnaire on page 2 and 3 of Annexure A. In instances where a recommendation for award of a bid will be made to a foreign bidder, the South African Weather Service will submit the bidders completed Annexure A bid document to the South African Revenue Service. The South African Revenue Service will then issue a confirmation of tax obligations letter to the South African Weather Service confirming whether or not the foreign entity has tax obligations in South Africa.



General Conditions of Contract

1. Definitions	1.	The following terms shall be interpreted as indicated:
	1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
	1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
	1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
	1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
	1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
	1.6	"Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
	1.7	"Day" means calendar day.
	1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
	1.9	"Delivery ex stock" means immediate delivery directly from stock actually on hand.
		"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such

		obligations of the supplier covered under the contract.
		Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.
2. Application	2.1	These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
	2.2	Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
	2.3	Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.
3. General	3.1	Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
	3.2	With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za
4. Standards	4.1	The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
5. Use of contract documents and information; inspection.	5.1	The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
	5.2	The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
	5.3	Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.

1 DESCRIPTION

The South African Weather Service (SAWS) seeks to apoint a Service Provider to provide security services to the SAWS Waterkloof vacant land. The Security services need to include 24-hours access control to the Land, physical patrol of the property, protection of SAWS vacant land, visitors, stakeholders, assets and the surrounding areas for a period of three (3) years.

2 INTRODUCTION

The SAWS is a Public Entity of the Department of Forestry, Fisheries and the Environment (DFFE) and derives its mandate from the South African Weather Service Act, Act No 8 of 2001 as amended. The SAWS is listed as a Schedule 3A Public Entity in terms of the Public Finance Management Act (PFMA).

The SAWS is tasked, amongst others, with providing timely and accurate scientific data in the field of meteorology to the broader South African society: a combination of both public good and commercial services. The organization plays a vital role in South African public life, not just as a provider of key services, but also in empowering citizens to adapt to the effects of the ever-changing weather.

The Waterkloof vacant Land, (Premise where security services are required), is situated at Waterkloof Heights, **225 Matroosberg, at the end of Matroosberg Road.**

3 BACKGROUND

The scope includes the protection and safeguarding of the SAWS Waterkloof vacant land, SAWS employees, property, stakeholders and physical patrolling of the property and the surrounding area.

The SAWS seeks the expertise of a professional security service provider to perform the security services for a period of three years.

The size of the land is approximately 37 hectors, with 30–35-degree slopes on the north, westerly and southern (N1 Highway) side and an almost 90-degree slope on the eastern side of the property.



4 REQUIREMENT / SCOPE OF WORK

4.1 Waterkloof Armed Security Service:

The SAWS, invites suitably qualified Service Providers to submit bids for the provision of 24-hours physical security and access to armed response services as described below:

- 4.1.1 Protection of the SAWS personnel, vacant land, visitors and stakeholders within the vacant land and surrounding area. The required service includes provision of the following:
 - a) Access control monitoring and provision of armed response.
 - b) Prohibit access to the vacant land by anyone not authorised to be on the land, including illegal occupants.
 - c) Conduct physical patrolling in and around the perimeter fence of the land at a minimum twice a day and make sure any suspicious activity is attended to.
 - d) The security company should undertake a professional investigation, risk assessment and written report after every incident.
 - e) Security Guards must have access to an armed response team when situation necessitates.
 - f) Reaction of an armed response team when a situation is developing or when the Guards notice suspicious movement / vehicles around the premises.
 - g) Daily integrity checks on security equipment and reporting of any faulty SAWS security equipment that may pose a security risk to personnel, assets and the premises.
 - h) Security Guards must also have access to and be trained to use the following as a minimum:
 - Trained security dogs
 - Accreditation as a Security Dog Handler with PSIRA.
 - Two-way radios for communication with each other and the response unit.
 - Emergency alert response device / panic button to alert armed response when required.
 - Self-defense tasers.
 - All equipment will be subject to regular testing.
 - The maintenance and repair of security guard equipment will remain the responsibility of the Service Provider.



- All security guards on site must be in full identifiable uniform of the company (suitable PPE), fully equipped i.e., safety shoes, rain gear, overcoats, two-way radio, pocketbook, and look professional.
- All equipment supplied must be in good working condition.
- Weekly visits by the Service Provider's management to ensure efficiency.
- Provision of monthly reports to the SAWS Facilities Manager or delegated person(s). Such reports must include the state of SAWS security infrastructure.
- The equipment must be new; no refurbished or grey products may be supplied.
- All equipment must be SABS approved.
- I) The Service Provider must have a direct link with either in house or outsourced emergency armed response for urgent response to any emergency upon hearing an emergency alert from the SAWS vacant land.
- J) The Service Provider must make provisions for mobile ablution services, portable drinkable water supply, waste collection and disposal.
- H) The Service Provider must be in compliance with Tariffs and Rates charged, in accordance with those prescribed by PSIRA Sectorial Determination as per respective security classification.
- **4.1.2** All partners, directors and employees of the successful service provider must be registered individually with PSIRA, as specified by PSIRA ACT 56 of 2001.

4.1.3 Reaction Officers

- a) The reaction officers must provide proof of authorization to practice as a reaction officer as prescribed by statute.
- b) The reaction officer is expected to react to the emergency situation within 15 minutes.
- c) The reaction team to be within Erasmusrand or anywhere within the Waterkloof area for reaction purposes.
- d) The reaction officer must display proof of identity on his person while on duty or while in the SAWS premises.
- e) The ID should be in the form of a tag or laminated plastic card and should display the following: Name, Photograph, Company name and telephone number, PSIRA registration number and the expiry date.



4.1.4 Reaction Officer Equipment While on duty a reaction officer must all times have the following with him / her:

- a) Firearm (Validly licensed)
- b) Torch
- c) Black pen
- d) Watch
- e) Pocketbook
- f) Hand cuffs and key / Suitable cable ties
- g) Bullet resistant vest
- h) Response slips or suitable notification of visit
- i) ID card
- j) Navigation system / GPS for night shift patrolling
- k) Raincoat
- I) Driver's license
- m) Firearm competency card
- n) Cellphone/two-way communication radio linked to control room.

4.2 Safety Requirements

The independent Service Provider shall ensure compliance with the relevant provisions of the Occupational Health and Safety Act, Act No. 85 of 1993 ("the OHS Act), and all safety regulations and procedures prescribed under the regulations of the OHS Act.

All incidents (including OHS incidents) should be reported to SAWS and a preliminary investigation report be provided within 24 hours. The final incident investigation report must be provided within seven (7) days. Security Officers should observe the provisions of Criminal Procedure Act (Act 51 of 1977) and all relevant legislations regarding the use of minimum force. Security Officers should at all-time use the minimum force sufficient to bring the situation under control and such force shall cease as soon as the situation is brought under control. No deliberate assault on suspects will be condoned.

4.4 Site induction

The Service Provider's staff members must undergo induction training regarding the site. The SAWS as the landowner will provide initial site induction and briefing, however the onus lies upon the Service Provider appointed to provide their own emergency plan for the site. This induction is compulsory and must be attended by the Security Company owner or representatives, supervisors, and armed response personnel. During the induction, the SAWS will provide the Security Company with relevant site-specific information



and regulations. It is the Security Company's responsibility to ensure that all newly appointed armed response officers on site are introduced to the SAWS and inducted before placement on site.
