## **B. REQUEST FOR PROPOSAL FOR SUPPLY, INSTALLATION AND DELIVERY OF AIR-CONDITIONER**

### **1. BACKGROUND TO SANS**

The South African National Space Agency (SANS) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

### **2. SCOPE OF WORK (TERMS OF REFERENCE)**

The Houwteq facility (GPS coordinates: -33.50877, 19.54124) is situated just past Grabouw in the Western Cape. The facility requires supply and installation of an air conditioner for the server room.

The successful bidder will be responsible for:

- Installation and commissioning of a new split-unit air conditioner in the server room.
- There is no existing hardware / infrastructure to be removed.
- **Provide maintenance and support for a period of 3 years on the solution.**

#### **Server Room Specifications**

- Server Room located in multi-story office building on ground floor.
- Dimensions: 5 x 8 x 3m (approx. 120m<sup>3</sup> volume)
- 3 x 19" server cabinets of which a total of 8 servers normally active.
- 36 000 BTU unit or bigger (check server room volume and confirm).
- Three-phase power available.
- Air conditioner parts to be treated with anticorrosion treatment such as from Bluchem.
- Air conditioner to have a network BACNet interface for future interfacing to a Building Management System (include additional gateway devices if needed).
- use the following estimate distances when quoting:
  - Indoor unit to external unit: 20m
  - Indoor unit to electrical distribution board: 15m
  - Electrical distribution board to external unit: 20m
  - (Final invoice will indicate the specific length of cable and piping that was used in the installation).

#### **Requirements from Bidder:**

- Install inside unit above server room double entry doors – cold air to blow to the front of the server cabinets.
- The air conditioning piping to run inside adjacent office's suspended ceiling.
- The outside unit to be mounted between the ground floor and first floor as well as to the one side of the building to prevent baboons having access to it.
- The electrical distribution board is available next to the server room with a passage between the two rooms. Suitable isolators and circuit breakers to be installed by a qualified electrician. CoC to be issued on final installation.

**Notes:**

- A detailed quote to be provided by the bidder.
- Provision to be made for servicing of the air conditioner every 6 months.
- Warranty and maintenance to be included for a period of 3 years, billed annually.

**C. EVALUATION CRITERIA**

SANSA promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

The procedure for the evaluation of responsive tenders is **price, functionality (quality) and preference** method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of 70 points explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation
- Thereafter, only the qualifying bids are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be

awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below

### 3. Quality/Functionality:

Scores will be tabulated to 100 points. Respondents must score **70 points** and over to be assessed on their financial offer and preference score.

#### Evaluation criteria 1: Technical Proposal / Approach

**Description:** The proposal should articulate what the bidder is offering for the price tendered in the pricing schedule. This should include a company profile, project methodology (timelines, etc) and a detailed list (design) of equipment that will be used for the installation.

The scoring of the service proposal will be as follows:

### Evaluation criteria 3: Service Level Agreement

This criteria evaluates typical response times for emergency events.  
The scoring of this criterion will be evaluated as follows:

### Evaluation Criteria 4: Warranties

This criteria evaluates the available hardware maintenance warranties provided by the bidder.

- e. All pages of quotation must be signed by the authorised person
- f. SANSA has the right to withdraw any quotation at any time within the validity of the quotation.
- g. SANSA reserves the right to invite suppliers/companies to present their bid proposals for final decision
