
Scope of Services

- Ensure availability of special dietary options, including Halaal, gluten-free, vegetarian and dairy-free meals.
- Provide a wide range of beverages, such as coffee, tea, juices, smoothies and soft drinks.
- Consider digital convenience features, including pre-ordering systems and weekly menus.
- Eskom will implement the Food and Beverage service via a Lease Agreement. This agreement will include provisions to cover basic utility costs such as water and electricity. Service providers should factor this arrangement into their operational planning and pricing models.
