The purpose of this letter is to present the specification presented to the Bid Specification Committee Meeting held on 14 May 2026 to the Accounting Officer for approval.

1.1 PURPOSE

The purpose of this report is to finalise the specifications for the above-mentioned bid for final approval by the accounting office prior to advertisement.

1.2 BACKGROUND

The Kgetlengrivier Local Municipality seek to appoint a Contractor for The upgrade of 11KV Koster switching substation.

1.3 LEADING DEPARTMENT

This request is being made by Technical Services department.

PART B

2. PROJECT SCOPE AND SCHEDULE OF WORKS

The project scope shall include but not limited to the following items:

- Replace all Primary Plant equipment
- Upgrade protection System and review settings

- Repair and revamp the Control Building
- Replace battery bank and charger
- Design and install a new System with issue of COCs
- Design and Install a New Security System for the Building

2.2. The schedule of works shall be carried out as below:

- Clean all drainage channels in the substation yard.
- Repair the control building roof.
- Service the 500kVA local Transformer and RMU.
- Replace the 110V DC battery bank.
- Install all missing and faded safety signage.
- Procurement for the complete replacement of the 11kV oil circuit breakers with modern SF6 or Vacuum Circuit Breaker panels.
- Conduct a comprehensive transformer maintenance program on T1 and T2, including Detailed Oil Analysis (DGA, Furan) and Power Factor testing.
- Phase 1 Protection Upgrade: Replace the old electromechanical relays with modern numerical relays for the transformer and feeder circuits.
- Execute the full replacement of the 11kV switchgear.
- Protection Upgrade: Complete the replacement of all protection relays and integrate with a new SCADA/RTU system for full remote monitoring and control.
- Develop a long-term asset management plan for the entire switching station, including a 10-year investment strategy.
