- 1 **Agreement**

- 3 **Alteration or Qualification of Bid**

- 4 **Authorised Signatory**

 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the provider and not involving the provider's fault or negligence and not foreseeable. The above documentation did not include necessarily all the documentation that may be needed by the Supply Chain department which must also be requested.
