<p><b>Environmental Aspects and Impacts Register</b>                      The contractor shall determine the aspects related to the scope of work. An aspect is an element of an organization’s activity, products, or services that may interact with the environment and may cause a negative or positive impact. Changes to the environment, either adverse or beneficial, that result wholly or partially from environmental aspects are called environmental impacts. The environmental impact can occur at local, regional, and global scales, and can also be direct, indirect, or cumulative by nature.
