LEASING OF OFFICE BUILDING FOR MUNICIPAL TRAFFIC DEPARTMENT

Laingsburg Municipality hereby invites suitably qualified and experienced property owners or authorised managing agents to submit tenders for the **leasing of an office building** to accommodate the municipal traffic department for a period of three (3) years.

The Municipality intends to lease a functional, compliant and secure office building within the Laingsburg municipal area.

This tender is subject to eligibility criteria and bidders must provide proof where required, as specified in the tender document.

Non-compliance with the eligibility criteria will render the bidder non-responsive.

The successful tenderer must also be registered and tax-compliant on the Centralised Supplier Database (CSD). Tenderers can register on www.csd.gov.za.

Tenders may only be submitted on the prescribed tender documents that are obtainable from **Friday, 5 June 2026** at the **Supply Chain Management Unit, 02 Van Riebeeck Street, Laingsburg, 6900** during office hours (**08h00 - 16h00**).

A non-refundable participation fee of **R 700.00 (Seven Hundred Rand)** will be applicable. The participation fee must be deposited into the account of the Laingsburg Municipality at **Standard Bank**, Branch Code **51108**, Account Number **203 247 663**. The reference number for confirmation of payment is **SCM-T-2026-27-001 - Company Name**.

Completed tenders in a sealed envelope, endorsed with **“SCM-T-2026-27-001 - Leasing of office building for municipal traffic department,”** must be placed in the tender box in the foyer between 08:00 – 15:00 at the Municipal Buildings, 02 Van Riebeeck Street, Laingsburg to reach the Municipal Manager no later than **12:00 p.m. on 9 July 2026**, after which tenders will be opened in public.

Telegraphic, telephonic, facsimile, emailed, and late bids will not be accepted.

The bid must be valid for a period of 120 days after the closing date. The bid will be subject to the Council's Supply Chain Management Policy, the Municipal Preferential Procurement Policy, and the Preferential Procurement Regulations, 2022.

The preferential points system applied (80/20) in terms of the Preferential Procurement Policy is as follows:

NO BIDS WILL BE CONSIDERED FROM PERSONS IN THE SERVICE OF THE STATE AS DEFINED IN THE MUNICIPAL SUPPLY CHAIN MANAGEMENT REGULATIONS (GOVERNMENT GAZETTE NO. 40553 DATED 20 JANUARY 2017).
