2.1.3 Any clarification required by a bidder regarding the meaning or interpretation of the Terms of Reference, or any other aspect concerning the bid, is preferably to be requested prior to the meeting by email to briefingsessions@nersa.org.za. Bidders are advised to study this document before attending the meeting.

2.1.4 It is the responsibility of bidders to take their own notes during the virtual briefing session. However, all those attending will be issued with summarised minutes of the session before the closing date of bid, forwarded electronically upon request.

2.1.5 Bidders who arrive after the compulsory briefing session has ended will not be allowed to submit their bids.

3 CLARIFICATIONS/ QUERIES

3.1.1 Any clarification required by a bidder regarding the meaning or interpretation of the Terms of Reference, or any other aspect concerning the bid, is to be requested **from the date of publication** in writing by e-mail from briefingsessions@nersa.org.za not later than 12:00 on the **29 June 2026**. No clarification will be attended to after this closing time. Therefore, bidders are encouraged to send questions before the briefing session date to be attended prior to the meeting.

3.1.2 A reply will be forwarded on **30 June 2026**. The bid reference number should be mentioned in all correspondence. Telephonic requests for clarification will not be accepted. If appropriate, the clarifying information will be made available to all bidders by e-mail only.

4 SUBMITTING BIDS

4.1.1 One (1) original of the bid document plus one (1) **memory stick (USB)** that contains the duplicate of the original submission to be handed in / delivered to: The Procurement Manager, NERSA, Kulawula House, 526 Madiba Street, Arcadia, Pretoria.

- 4.1.2 The original version of the bid must be submitted with one (1) memory stick. The original bid document must be fully completed and/or signed in ink and thereafter duplicate the original in the memory stick with all its attachments. In addition, Bidders must submit a memory stick sealed in a closed envelope for submission.
- 4.1.3 An original bid document may not be converted into word format or retyped, however, may be completed/filled in ink.
- 4.1.4 **Bidders will be required to sign a tender register at the reception when dropping of the bids, therefore bidders are advised to arrive timeously.**
- 4.1.5 Bids should be submitted in a sealed envelope, marked with:

Documents submitted on time by bidders shall not be returned.

5 LATE BIDS

- 5.1.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be locked at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

The official Telkom time (Dial 1026) will be used to verify the exact closing time.

- 5.1.2 Bids sent to NERSA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NERSA premises (in tender box in reception area or if too big for the tender box, over the counter in the reception area). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

7 NEGOTIATION AND CONTRACTING

- 7.2 NERSA has the right to enter into negotiation with one or more bidders regarding any terms and conditions, including price(s), of a proposed contract.
- 7.3 NERSA shall not be obliged to accept the lowest of any quotation, offer or proposal.
- 7.4 A contract will only be deemed to be concluded when reduced to writing in a formal contract and Service Level Agreement signed by the designated responsible person of both parties. The designated responsible person of NERSA is the Chief Executive Officer (CEO) or his/her written authorised delegate.
- 7.5 Under no circumstances will negotiation with any bidders constitute an award or promise / undertaking to award the contract.

8 ACCESS TO INFORMATION

All bidders will be informed of the status of their bid once the procurement process has been completed. Requests for information regarding the bid process will be dealt with in line with the NERSA procurement policy and relevant legislation.

9 REASONS FOR REJECTION

- 9.1 NERSA shall reject a proposal for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 9.2 NERSA may disregard the bid of any bidder if that bidder, or any of its directors:
- 9.3 Have abused the SCM system of NERSA.
- 9.4 Have committed proven fraud or any other improper conduct in relation to such system.
- 9.5 Have failed to perform on any previous contract and the proof exists.
- 9.6 Such actions shall be communicated to the National Treasury.

10 PAYMENTS

- 10.1 NERSA will pay the contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by NERSA to the contractor.
- 10.2 The contractor shall from time to time during the currency of the contract, invoice NERSA for the services rendered.
- 10.3 The invoice must be accompanied by supporting source document(s) containing detailed information, as NERSA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the contractor.
- 10.4 No payment will be made to the contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NERSA.
- 10.5 Payment shall be made by bank transfer into the Contractor's bank account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).
- 10.6 The Contractor shall be responsible for accounting to the appropriate authorities for its income tax, VAT or other moneys required to be paid in terms of the applicable law.
- 10.7 Method of Payment in respect of services delivered by the Contractor will be made monthly, subject to the submission of detailed invoices, and verification by NERSA staff or person designated. Invoices must be forwarded to invoice@nersa.org.za.

11 CANCELLATION OF PROCUREMENT PROCESS

This procurement process can be postponed or cancelled at any stage provided that such cancellation or postponement takes place prior to entering into a contract with a specific service provider to which the bid relates.

BIDDERS MUST TAKE NOTE OF THE STANDARD EVALUATION PROCESS

1 EVALUATION PROCESS

1.1 COMPLIANCE WITH MINIMUM REQUIREMENTS CRITERIA

All bids duly lodged as specified in this Request for Bid will be examined to determine compliance with bidding requirements and conditions. Bids with deviations from the requirements / conditions, will be eliminated from further consideration.

1.2 SELECTION CRITERIA, PRICE AND PREFERENCE POINTS

1.2.1 All remaining bids as per paragraph 1.1 will be evaluated as follows:

1.2.2 Bids will be evaluated first on selection criteria and then in accordance with the 80/20 reference points system prescribed in Preferential Procurement Regulations.

1.2.3 The First stage, bids will be evaluated on selection criteria, of which (100 points) shall be awarded on selection criteria evaluation.

1.2.4 Bids will be considered further if it achieves the minimum prescribed qualifying score for selection criteria (60.00 points out of 100). Bids that failed to achieve the minimum qualifying score on selection criteria will be disqualified for further evaluation.

1.2.5 The Second stage, bids will be evaluated in terms of the 80/20 preference point systems. Only bids that achieve the minimum qualifying score/percentage on selection criteria will be evaluated in accordance with the 80/20 preference point system.

1.3 DETERMINATION OF PERCENTAGE FOR SELECTION CRITERIA

1.3.1 The evaluation criteria and weights on selection criteria as indicated in the table in paragraph 2, will apply.

1.3.2 The percentage scored on selection criteria should be calculated as follows:

1.3.3 Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score. The following formula should then be used to convert the total score to a percentage on selection criteria:

$$Ps = \frac{So}{Ms} \times Ap$$

Where

Ps = percentage scored on selection criteria /proposal under consideration

So = total score of bid/proposal under consideration

Ms = maximum possible score

Ap = percentage allocated on selection criteria

1.3.4 The percentages of each panel member shall be added together and divided by the number of panel members to establish the average percentage obtained by each individual bidder on selection criteria evaluation.

1.4 ELIMINATION OF PROPOSALS ON GROUNDS OF SELECTION CRITERIA

- 1.4.1 Bids that score less than **60%** of the marks available on selection criteria evaluation will be eliminated from further consideration.
- 1.4.2 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.4.3 The percentage scored for price shall be calculated as follows:

A maximum of 80 points is allocated for price on the following basis:

80/20

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

- P_s = Points scored for comparative price of bid under consideration
 P_t = Comparative price of bid under consideration
 P_{\min} = Comparative price of lowest acceptable bid

1.5 AWARDING OF POINTS FOR SPECIFIC GOALS

- 1.5.1 Points to be awarded to a bidder based on his or her specific goals see below table:

1.6 COMBINING PRICE AND SPECIFIC GOALS

- 1.6.1 The points for specific goals will now be added to the price.
- 1.6.2 Only the bid with the highest number of points scored may be selected for award.
- 1.6.3 The Bid Adjudication Committee will consider the recommendations and make the final award. The successful bidder will usually be the bidder scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.

1.7 PRESENTATIONS (optional)

- 1.7.1 NERSA reserves the right to invite bidders for presentations before the award of the bid.
- 1.7.2 NERSA may decide to have compulsory presentations made either by all bidders who have obtained at least **60%** of the marks on selection criteria evaluation, or by the bidders ranked first, to third once the selection criteria, price and preference marks have been combined.
- 1.7.3 Presentations shall only affect the marks awarded on selection criteria evaluation. If NERSA wishes to use presentations to discriminate between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme and indicated in paragraph 1.2 above.
- 1.7.4 If the date of the presentation meeting is not indicated in the bid document, at least three days' notice will be given to bidders required to attend a presentation as well as the detail of the venue for the presentation.
- 1.7.5 Presentations will be made to the full Bid Evaluation Committee.
- 1.7.6 Points determined by the presentation will be awarded to each bidder by each member of the Bid Evaluation Committee and then an average calculated.
- 1.7.7 Under no circumstances will a presentation by any bidder constitute an award or promise / undertaking to award the contract.

1.8 ADJUDICATION OF BID

- 1.8.1 The Bid Adjudication Committee will consider the recommendations and make the final award. The successful bidder will usually be the bidder scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.

2 EVALUATION CRITERIA (APPLICABLE TO BID)

Bidders will be evaluated in terms of the 80/20 preferential point system in accordance with the Supply Chain Management Policy of NERSA as well as the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000) and Preferential Procurement Regulations of 2022.

The bid evaluation process shall be carried out in three (3) stages namely:

- Stage 1: Administrative Requirements
- Stage 2: Selection Criteria (minimum score of 60 points to proceed to stage 3)
- Stage 3: Price and Specific Goals

2.1 Stage 1: Compliance with minimum requirements (Administrative Requirements)

In case of a consortium / joint venture, a consolidated B-BBEE certificate should be submitted for unincorporated entities. The Organisation wishing to claim points should complete the Preference Points Claim Form (Purchases).
- Registration on the National Treasury Central Supplier Database (CSD) prior to submitting their bids. Proof of CSD registration summary report must be submitted together with the proposal or Central Supplier Database Number must be provided on the first page of the SCM forms. Failure to submit proof of CSD registration (a CSD registration summary report or the MA Number on the first page of the SCM forms) will invalidate the bid. 2.2 Stage 2: Evaluation on selection criteria

The evaluation will be conducted by an evaluation panel that will evaluate all proposals. All proposals will be evaluated by the evaluation panel independently in terms of the evaluation criteria for functionality, which will be made up of 100 points as follows:

1. INTRODUCTION

2. PROJECT BACKGROUND AND CONTEXT

2.1 The National Energy Regulator of South Africa (NERSA) seeks to appoint a service provider to maintain, support, host, and enhance the NERSA's website on an as and when required basis for a period of three (3) years.

2.2 NERSA's website was redesigned, redeveloped, and launched in 2021. NERSA's website requires continuous maintenance, support and enhancements on an as and when required basis. NERSA also requires the services of hosting the NERSA's website for the duration of the contract with a prospective service provider.

2.3 The NERSA's website is one of the most important communication tools to create awareness as well as to inform all stakeholders nationally as well as internationally about the legislative mandate, responsibilities and functions of the entity. The NERSA's website is also used as a mouthpiece to reflect the latest developments within the entity, as well as the energy industry.

3. PURPOSE

3.1 The National Energy Regulator of South Africa (NERSA) seeks to appoint a service provider to maintain, support, host, and enhance the NERSA's website on an as and when required basis for a period of three (3) years.

4. SCOPE OF WORK AND DELIVERABLES

The prospective service provider is required to provide NERSA with a proposal/quotation of the following items as detailed below:

4.1 The prospective service provider shall maintain, support, host, and enhance the NERSA's website on an as and when required basis for a period of thee (3) years.

4.2 The prospective service provider shall maintain, support, host, and enhance the NERSA's website in line with NERSA business requirements.

4.3 NERSA website is a knowledge Hub with vast information. The organisation will require the functionality of a Chatbot to improve stakeholder engagement.

4.4 The service deliverables shall include, but not limited to the following:

4.4.1 Server configuration

Server Hardware Configuration

The dedicated hosting environment must provide sufficient computing resources to support the bespoke application framework, database processing, document retrieval, and search indexing operations.

Minimum configuration:

This memory allocation supports PHP-FPM worker execution, MySQL processing, document handling, and caching processes.

4.4.2 Server Infrastructure Specifications

The NERSA internet application platform operates within a dedicated hosted server environment designed to support a bespoke PHP web application, a structured regulatory document repository, workflow-based backend administration, and search indexing across

a high-volume content base. The hosting environment must support the continuous operation of the public website, the backend content and document administration platform, the document workflow application, the event calendar module, and all associated search and metadata processes. The infrastructure must be configured as a dedicated hosted environment and not as a shared hosting instance.

4.4.3 Network and Connectivity

The hosting infrastructure must support stable and secure public access.

Requirements include:

- static IP allocation
- unlimited or unmetered bandwidth
- secure remote administrative access

The platform must support HTTPS access for both public website traffic and secure administrative login.

The existing production environment confirms operation over HTTPS with Apache web services and HTTP/2 enabled

4.4.4 Security Configuration

The server environment must include appropriate security controls for public-facing regulatory website and administration system.

Security controls include:

The current environment confirms secure PHP runtime controls including disabled production error display and restricted file access configuration

4.4.5 Administrative Management Tools

The hosting environment must provide administration utilities required for system management and maintenance.

- PHP-FPM worker pool management
- MySQL performance tuning
- temporary storage support for document uploads and processing

The current PHP runtime confirms active Zend OPcache caching and Memcached extension support.

4.4.8 Software Specifications

The NERSA internet application system operates on a bespoke PHP application platform designed specifically to support regulatory publishing, document management, and structured website administration.

The platform has been developed specifically for the NERSA environment and does not rely on generic content management systems or commercial web frameworks.

The software architecture supports regulatory document publishing, structured content management, search indexing, event management, media control, and metadata management.

4.4.9 Application Architecture

The website is built on a custom PHP application framework and a dedicated backend administration system.

The administration platform manages all front-end website components and structured content relationships.

The system architecture supports:

- workflow-driven document publishing
- structured site node management
 - content management
 - media management
 - document management
- search indexing
- SEO metadata administration
- homepage display control
- document categorisation and expiry management
- event calendar publishing

The administration interface is purpose built to manage front-end content structures and document relationships.

4.4.14 Document Repository and Workflow Application

The website includes a structured document repository used to manage regulatory publications.

The repository currently contains approximately 7,632 indexed document records managed through a document workflow application.

The document workflow system supports:

- adding documents to multiple categories
 - assigning multiple documents to a single publication record
 - keyword tagging for search indexing
 - document expiry by date and time

- assignment of documents to homepage banner displays
- assignment of documents to homepage latest publication sections

This allows documents to appear across multiple public content areas while being managed through a single backend record.

Search and Indexing

The document repository uses a structured search indexing system.

The current architecture includes:

- ElasticSearch indexing
- NLM-based filtered document lookup logic

The search system supports:

- keyword searches
- metadata filtering
- category filtering
- indexed retrieval of document records

This indexing approach allows fast retrieval of regulatory publications and related records.

Backend Content and Site Management

The backend administration platform provides management tools for all website components.

The administration system supports:

- site node and navigation management
- page and content editing
- metadata and SEO field management
- document management
- media management
- workflow configuration
- homepage content placement

The backend system controls both page content and structured document relationships within the website.

Event Calendar Management

The platform includes an integrated event calendar management module.

The event module allows administrators to:

- manage event schedules
- publish event information
- manage event metadata

Events are displayed on the public website through automated event listing views.

System Compatibility and Continuity

The hosting and software environment must support the continued operation of the existing bespoke PHP application architecture.

The environment must support:

- the structured regulatory document repository
- document workflow management processes
- metadata-driven publishing
- ElasticSearch based search indexing

The hosting and software environment must therefore support the ongoing operation of this architecture while maintaining compatibility with the existing application components and data structures

4.4.15 System requirements

4.5.1 Maintenance
