In this Request for Proposals, unless a contrary intention is apparent:

- 1.3 **B-BBEE status level** means the B-BBEE status received by a measured entity based on its overall performance used to claim points in terms of regulation 5 and 6 of the Preferential Procurement Regulations, 2011.
- 1.4 **Business Day** means a day which is not a Saturday, Sunday or public holiday.
- 1.5 **Bid** means a written offer in the prescribed or stipulated form lodged by a Bidder in response to an invitation in this Request for Proposal, containing an offer to provide goods, works or services in accordance with the Specification as provided in this RFP.
- 1.6 **Bidder** means a person or legal entity, or an unincorporated group of persons or legal entities that submit a Bid.
- 1.7 **Companies Act** means the Companies Act, 2008.
- 1.8 **Compulsory Documents** means the list of compulsory schedules and documents set out in Part B.
- 1.9 **Closing Time** means the time, specified as such under the clause d Timetable) in Part C, by which Tenders must be received.
- 1.10 **DBSA** means the Development Bank of Southern Africa.
- 1.11 **DFI** means development finance institution.
- 1.12 **Evaluation Criteria** means the criteria set out under the clause 26 (Evaluation Process) of this Part C, which includes the Qualifying Criteria, Functional Criteria and Price and Preferential Points Assessment.
- 1.13 **Functional Criteria** means the criteria set out in clause 0 of this Part C.
- 1.14 **Intellectual Property Rights** includes copyright and neighbouring rights, and all proprietary rights in relation to inventions (including patents) registered and unregistered trademarks (including service marks), registered designs, confidential information (including trade secrets and know how) and circuit layouts, and all other proprietary rights resulting from intellectual activity in the industrial, scientific, literary or artistic fields.
- 1.15 **PFMA** means the Public Finance Management Act, 1999.
- 1.16 **Price and Preferential Points Assessment** means the process described in clause 0 of this Part C, as prescribed by the PPR 2022.
- 1.17 **Proposed Contract** means the agreement including any other terms and conditions contained in or referred to in this RFP that may be executed between the DBSA and the successful Bidder.
- 1.18 **Qualifying Criteria** means the criteria set out in clause of this Part C.

- 1.19 **Request for Proposal** or **RFP** means this document (comprising each of the parts identified under Part A, Part B, Part C and Part D) including all annexures and any other documents so designated by the DBSA.
- 1.20 **SARS** means the South African Revenue Service.
- 1.21 **Services** means the services required by the DBSA, as specified in this RFP Part D.
- 1.22 **SLA** means service level agreement.
- 1.23 **SOE** means State Owned Enterprise, as defined by the Companies' Act.
- 1.24 **Specification** means the conditions of tender set and any specification or description of the DBSA's requirements contained in this RFP.

- 4.2 Bidders are to provide 2 Folders (1) **Technical proposal** and (2) **Pricing proposal** only.
- 4.3 **NOTE: This Tendering Process will use a two-envelope system i.e. Bidders must submit the Qualifying Criteria and Functional Proposal in One Folder (together with relevant copies) & Pricing and Preference Points Proposals in a separate folder (together with the relevant copies). BOTH FOLDERS MUST BE CLEARLY LABELLED IN LINK. Should you fail to adhere to this, the bidders will be disqualified.**

5. RULES GOVERNING THIS RFP AND THE TENDERING PROCESS

- 5.1 Participation in the tender process is subject to compliance with the rules contained in this RFP Part C.
- 5.2 All persons (whether or not a participant in this tender process) having obtained or received this RFP may only use it, and the information contained herein, in compliance with the rules contained in this RFP.
- 5.3 All Bidders are deemed to accept the rules contained in this RFP Part C.
- 5.4 The rules contained in this RFP Part C apply to:
- 5.4.1 The RFP and any other information given, received or made available in connection with this RFP, and any revisions or annexure.
 - 5.4.2 the Tendering Process; and
 - 5.4.3 any communications (including any briefings, presentations, meetings, and negotiations) relating to the RFP or the Tendering Process

6. STATUS OF REQUEST FOR PROPOSAL

- 6.1 This RFP is an invitation for companies to submit a proposal (s) for the provision of the services as set out in the Specification contained in this RFP. Accordingly, this RFP must not be construed, interpreted, or relied upon, whether expressly or implicitly, as an offer capable of acceptance by any person(s), or as creating any form of contractual, promissory or other rights. No binding contract or other understanding for the supply of services will exist between the DBSA and any Bidder unless and until the DBSA has executed a formal written contract with the successful Bidder.

7. ACCURACY OF REQUEST FOR PROPOSAL

- 7.1 Whilst all due care has been taken in connection with the preparation of this RFP, the DBSA makes no representations or warranties that the content in this RFP or any information communicated to or provided to Bidders during the Tendering Process is, or will be, accurate, current or complete. The DBSA, and its officers, employees and advisors will not be liable with respect to any information communicated which is not accurate, current or complete.

- 7.2 If a Bidder finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this RFP or any other information provided by the DBSA (other than minor clerical matters), the Bidder must promptly notify the DBSA in writing of such discrepancy, ambiguity, error or inconsistency in order to afford the DBSA an opportunity to consider what corrective action is necessary (if any).
- 7.3 Any actual discrepancy, ambiguity, error or inconsistency in this RFP or any other information provided by the DBSA will, if possible, be corrected and provided to all Bidders without attribution to the Bidder who provided the written notice.

8. ADDITIONS AND AMENDMENTS TO THE RFP

- 8.1 The DBSA reserves the right to change any information in, or to issue any addendum to this RFP before the Closing Time. The DBSA and its officers, employees and advisors will not be liable in connection with either the exercise of, or failure to exercise this right.
- 8.2 If the DBSA exercises its right to change information in terms of clause 9.1, it may seek amended Tenders from all Bidders.

9. REPRESENTATIONS

No representations made by or on behalf of the DBSA in relation to this RFP will be binding on the DBSA unless that representation is expressly incorporated into the contract ultimately entered into between the DBSA and the successful Bidder.

10. CONFIDENTIALITY

- 10.1 All persons (including all Bidders) obtaining or receiving this RFP and any other information in connection with this RFP, or the Tendering Process must keep the contents of the RFP and other such information confidential and not disclose or use the information except as required for the purpose of developing a proposal in response to this RFP.

11. REQUESTS FOR CLARIFICATION OR FURTHER INFORMATION

- 11.1 All communications relating to this RFP and the Tendering Process must be directed to the Tender Manager.
- 11.2 All questions or requests for further information or clarification of this RFP or any other document issued in connection with the Tendering Process must be submitted to the Tender Manager by e-mail.
- 11.3 Any communication by a Bidder to the DBSA will be effective upon receipt by the Tender Manager (provided such communication is in the required format).

- 11.4 The DBSA has restricted the period during which it will accept questions or requests for further information or clarification and reserves the right not to respond to any enquiry or request, irrespective of when such enquiry or request is received.
- 11.5 Except where the DBSA is of the opinion that issues raised apply only to an individual Bidder, questions submitted and answers provided will be made available to all Bidders by e-mail, as well as on the DBSA's website without identifying the person or organisation which submitted the question.
- 11.6 In all other instances, the DBSA may directly provide any written notification or response to a Bidder by email to the address of the Bidder (as notified by the Bidder to the Tender Manager).
- 11.7 A Bidder may, by notifying the Tender Manager in writing, withdraw a question submitted in accordance with clause 12, in circumstances where the Bidder does not wish the DBSA to publish its response to the question to all Bidders.

12. UNAUTHORISED COMMUNICATIONS

- 12.1 Communications (including promotional or advertising activities) with staff of the DBSA or their advisors assisting with the Tendering Process are not permitted during the Tendering Process, or otherwise with the prior consent of the Tender Manager. Nothing in this clause 12 is intended to prevent communications with staff of, or advisors to, the DBSA to the extent that such communications do not relate to this RFP or the Tendering Process.
- 12.2 Bidders must not otherwise engage in any activities that may be perceived as, or that may have the effect of, influencing the outcomes of the Tendering Process in any way.

13. IMPROPER ASSISTANCE, FRAUD AND CORRUPTION

- 13.1 Bidders may not seek or obtain the assistance of employees of the DBSA in the preparation of their tender responses.
- 13.2 The DBSA may in its absolute discretion, immediately disqualify a Bidder that it believes has sought or obtained such improper assistance.
- 13.3 Bidders are to be familiar with the implications of contravening the Prevention and Combating of Corrupt Activities Act, 2004 and any other relevant legislation.

14. ANTI-COMPETITIVE CONDUCT

- 14.1 Bidders and their respective officers, employees, agents and advisors must not engage in any collusion, anti-competitive conduct or any other similar conduct in respect of this Tendering Process with any other Bidder or any other person(s) in relation to:
- 14.1.1 the preparation or lodgement of their Bid
 - 14.1.2 the evaluation and clarification of their Bid; and

14.1.3 the conduct of negotiations with the DBSA.

14.2 For the purposes of this clause 14, collusion, anti-competitive conduct or any other similar conduct may include disclosure, exchange and clarification of information whether or not such information is confidential to the DBSA or any other Bidder or any other person or organisation.

14.3 In addition to any other remedies available to it under law or contract, the DBSA may, in its absolute discretion, immediately disqualify a Bidder that it believes has engaged in any collusive, anti-competitive conduct or any other similar conduct during or before the Tendering Process.

15. COMPLAINTS ABOUT THE TENDERING PROCESS

15.1 Any complaint about the RFP or the Tendering Process must be submitted to the Tender Manager in writing, by email, immediately upon the cause of the complaint arising or becoming known to the Bidder.

15.2 The written complaint must set out:

15.2.1 the basis for the complaint, specifying the issues involved.

15.2.2 how the subject of the complaint affects the organisation or person making the complaint;

15.2.3 any relevant background information; and

15.2.4 the outcome desired by the person or organisation making the complaint.

15.3 If the matter relates to the conduct of an employee of the DBSA, the complaint should be addressed in writing marked for the attention of the Chief Executive Officer of the DBSA, and delivered to the physical address of the DBSA, as notified.

16. CONFLICT OF INTEREST

16.1 A Bidder must not, and must ensure that its officers, employees, agents and advisors do not place themselves in a position that may give rise to actual, potential or perceived conflict of interest between the interests of the DBSA and the Bidder's interests during the Tender Process.

16.2 The Bidder is required to provide details of any interests, relationships or clients which may or do give rise to a conflict of interest in relation to the supply of the services under any contract that may result from this RFP. If the Bidder submits its Bid and a subsequent conflict of interest arises, or is likely to arise, which was not disclosed in the Bid, the Bidder must notify the DBSA immediately in writing of that conflict.

16.3 The DBSA may immediately disqualify a Bidder from the Tendering Process if the Bidder fails to notify the DBSA of the conflict as required.

17. LATE BIDS

- 17.1 Bids must be loaded on one drive before the Closing Time. The Closing Time may be extended by the DBSA in its absolute discretion by providing written notice to Bidders.
- ~~17.2 Bids loaded after the Closing Time or lodged at a location or in a manner that is contrary to that specified in this RFP will be disqualified from the Tendering Process and will be ineligible for consideration. However, a late Bid may be accepted where the Bidder can clearly demonstrate (to the satisfaction of the DBSA, in its sole discretion) that late lodgement of the Bid was caused by the DBSA; that access was denied or hindered in relation to the physical tender box; or that a major/critical incident hindered the delivery of the Bid and, in all cases, that the integrity of the Tendering Process will not be compromised by accepting a Bid after the Closing Time.~~
- ~~17.3 The determination of the DBSA as to the actual time that a Bid is lodged is final. Subject to clause 17.2, all Bids lodged after the Closing Time will be recorded by the DBSA and will only be opened for the purposes of identifying a business name and address of the Bidder. The DBSA will inform a Bidder whose Bid was lodged after the Closing Time of its ineligibility for consideration. The general operating practice is for the late Bid to be returned within 5 (five) working days of receipt or within 5 (five) working days after determination not to accept a late Bid~~

18. BIDDER'S RESPONSIBILITIES

- 18.1 Bidders are responsible for:
- 18.1.1 examining this RFP and any documents referenced or attached to this RFP and any other information made or to be made available by the DBSA to Bidders in connection with this RFP;
 - 18.1.2 fully informing themselves in relation to all matters arising from this RFP, including all matters regarding the DBSA's requirements for the provision of the Services;
 - 18.1.3 ensuring that their Bids are accurate and complete;
 - 18.1.4 making their own enquiries and assessing all risks regarding this RFP, and fully considering and incorporating the impact of any known and unknown risks into their Bid;
 - 18.1.5 ensuring that they comply with all applicable laws in regard to the Tendering Process particularly as specified by National Treasury Regulations, Guidelines, Instruction Notes and Practice Notes and other relevant legislation as published from time to time in the Government Gazette; and
 - 18.1.6 submitting all Compulsory Documents.
- 18.2 The DBSA reserves the right to require of a Bidder, either before a Bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the DBSA.
- 18.3 Failure to provide the required information may result in disqualification of the Bidder.

19. PREPARATION OF BIDS

19.1 Bidders must ensure that:

19.1.1 their Bid is submitted in the required format as stipulated in this RFP; and

19.1.2 all the required information fields in the Bid are completed in full and contain the information requested by the DBSA.

19.2 The DBSA may in its absolute discretion reject a Bid that does not include the information requested or is not in the format required.

19.3 Unnecessarily elaborate responses or other representations beyond that which is sufficient to present a complete and effective tender proposal are not desired or required. Elaborate and expensive visual and other presentation aids are not necessary.

19.4 Where the Bidder is unwilling to accept a specified condition, the non-acceptance must be clearly and expressly stated. Prominence must be given to the statement detailing the non-acceptance. It is not sufficient that the statement appears only as part of an attachment to the Bid or be included in a general statement of the Bidders usual operating conditions.

19.5 An incomplete Bid may be disqualified or assessed solely on the information completed or received with the Bid.

20. ILLEGIBLE CONTENT, ALTERATION AND ERASURES

20.1 Incomplete Bids may be disqualified or evaluated solely on information contained in the Bid.

20.2 The DBSA may disregard any content in a Tender that is illegible and will be under no obligation whatsoever to seek clarification from the Bidder.

20.3 The DBSA may permit a Bidder to correct an unintentional error in its Bid where that error becomes known or apparent after the Closing Time, but in no event will any correction be permitted if the DBSA reasonably considers that the correction would materially alter the substance of the Bid or effect the fairness of the Tendering Process.

21. OBLIGATION TO NOTIFY ERRORS

If, after a Bidder's Response has been submitted, the Bidder becomes aware of an error in the Bidders Response (including an error in pricing but excluding clerical errors which would have no bearing on the evaluation of the Bid), the Bidder must promptly notify the DBSA of such error.

22. RESPONSIBILITY FOR BIDDING COSTS

22.1 The Bidders participation or involvement in any stage of the Tendering Process is at the Bidders sole risk, cost and expense. The DBSA will not be held responsible for, or pay for, any expense or loss that may be incurred by Bidders in relation to the preparation or lodgement of their Bid.

22.2 The DBSA is not liable to the Bidder for any costs on the basis of any contractual, promissory or restitutionary grounds whatsoever as a consequence of any matter relating to the Bidders participation in the Tendering Process, including without limitation, instances where:

22.2.1 the Bidder is not engaged to perform under any contract; or

22.2.2 the DBSA exercises any right under this RFP or at law.

23. DISCLOSURE OF BID CONTENTS AND BID INFORMATION

23.1 All Bids received by the DBSA will be treated as confidential. The DBSA will not disclose contents of any Bid and Bid information, except:

23.1.1 as required by law;

23.1.2 for the purpose of investigations by other government authorities having relevant jurisdiction;

23.1.3 to external consultants and advisors of the DBSA engaged to assist with the Tendering Process; or for the general information of Bidders required to be disclosed as per National Treasury Regulations, Guidelines, Instruction Notes or Practice Notes.

24. USE OF BIDS

24.1 Upon submission in accordance with the requirements relating to the submission of Bids, all Bids submitted become the property of the DBSA. Bidders will retain all ownership rights in any intellectual property contained in the Bids.

24.2 Each Bidder, by submission of their Bid, is deemed to have licensed the DBSA to reproduce the whole, or any portion, of their Bid for the sole purposes of enabling the DBSA to evaluate the Bid.

25. BID ACCEPTANCE

All Bids received must remain open for acceptance for a minimum period of 120 (One Hundred and Twenty) days from the Closing Time. This period may be extended by written mutual agreement between the DBSA and the Bidder.

26. EVALUATION PROCESS

26.1 The Bids will be evaluated and adjudicated as follows:

26.1.1 FIRST STAGE – RESPONSIVENESS -COMPLIANCE CRITERIA

Only those Bidders which satisfy the compliance criteria will be eligible to participate in the Tendering Process further. Bids which do not satisfy all of the compliance criteria will not be evaluated further.

26.1.2 SECOND STAGE – FUNCTIONAL EVALUATION

Bidders are evaluated based on the functional criteria set out in this RFP. Only those Bidders which score **70** points or higher (out of a possible 100) during the functional evaluation will be evaluated during the second stage of the Bid.

26.1.3 THIRD STAGE – PRICE AND PREFERENTIAL POINTS

26.1.3.1 Those Bidders which have passed the above stages of the tender process will be scored on the basis of price and preference point allocation in accordance with the applicable legislation.

26.1.4 FOURTH STAGE – RISK ANALYSIS

26.1.4.1 Firstly, in addition to the financial offer and preference evaluation, the Tenderers having the highest ranking / number of points, will additionally be reviewed against the following points listed as “**Other Objective Criteria**” in terms of the PPR 2022, in order to ascertain suitability for award.

- i) The tenderer will again be checked in terms of having a Compliant Tax Status at time of recommendation to confirm that the status has not changed, based on an active and Tax Complaint Pin issued by the South African Revenue Services.
 - ii) Fully compliant and registered with the National Treasury Central Supplier Database.
 - iii) No misrepresentation in the tender information submitted.
 - iv) The tenderer or any of its directors/shareholders is not listed on the Register of Tender Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector; and
 - v) The tenderer has completed the Compulsory Enterprise Questionnaire and there are no conflicts of interest which may impact on the tenderer’s ability to perform the contract in the best interests of the employer or potentially compromise the tender process and persons in the employ of the state are permitted to submit tenders or participate in the contract.
 - vi) Convicted by a court of law for fraud and corruption.
 - vii) Removed from a contract between them and any organ of state on account of failure to perform on or comply with the contract.
 - viii) The DBSA reserves the right to make a decision on contract award based solely on the information received in the responses to this RFP. The DBSA also reserves the right to use relevant information not contained in any tender but which, in the ordinary course of business, is within the knowledge of any employee or Board member of DBSA or its advisors, agents or representatives for the purposes of making its decision.
 - ix) Any bidder who has had a tender award terminated by the DBSA for non-performance during the 18 months preceding the closing date of this RFP, may at the discretion of the DBSA, be excluded from recommendation for further under this RFP. In addition, any bidder who has received a written notice of non-performance in the 12-month period preceding the award of this RFP, may at the discretion of the DBSA, be excluded from recommendation for further awards until the non-performance, or the circumstance giving rise to the non-performance, has been remedied to the satisfaction of the DBSA.

 - iii. The offer of award will be informed by the best Value for Money, Risk Allocation and Risk Profile of the bidder.
 - *Value for Money* = Improved total cost.
 - *Risk Allocation* = Considering other awards, including the logistical allocation of other projects.
 - *Risk Profile* = Considering the profiles of entities, such as Procure Check, PEP Checks and Directorship to name a few.

 - xi. Tenderer is required to adhere to the Pricing Instructions as detailed, failing which will result in offer being deemed non-compliant. Where noted that a cost item was not priced, clarification will be issued to clarify reason, without allowing any costs to be amended or included.
- The below conditions *xii* and *xiii* are NOT APPLICABLE.
- xii. Tenderer may not propose any resources that have been allocated on a project that has been awarded by DBSA and is less than 85% complete.
 - xiii. The resources tendered will be assessed to verify that they are not offered on another project with less than 85% completion. Should such an occurrence transpire, a clarification will be issued to allow the tenderer to replace the applicable resource/s within 48 hrs, failing which, the bid will be excluded from recommendation.

- 29.3.2 provide references or additional information;

30 SUCCESSFUL BIDS

- 30.1 Selection as a successful Bidder does not give rise to a contract (express or implied) between the successful Bidder and the DBSA for the supply of the Services. No legal relationship will exist between the DBSA and a successful Bidder for the supply of the Services until such time as a binding contract is executed by them.

TERMS OF REFERENCE

RFP060/2026: APPOINTMENT OF A PROFESSIONAL SERVICE PROVIDER TO PROVIDE TECHNICAL SUPPORT ON PUBLIC TRANSPORT BUS DEVOLUTION PROJECT UNDER NATIONAL TREASURY CITIES SUPPORT PROGRAMME

1. PURPOSE

The purpose of the terms of reference is to appoint a suitably qualified service provider to provide targeted technical support to selected metropolitan municipalities and the National Department of Transport (NDoT) to advance the operationalisation of the devolution of the commuter bus contracting function, in line with the National Land Transport Act (NLTA).

2. INTRODUCTION

1.1 Background to the CSP

The Cities Support Programme (CSP) is located within National Treasury's Intergovernmental Relations (IGR) Division and acts as a change agent and vehicle for collaboration and integration. It aims to improve the capacity of cities and create an enabling intergovernmental fiscal system and policy environment to support improved spatial transformation and inclusive economic growth outcomes for the South African metropolitan municipalities (metros).

The CSP builds on the National Development Plan (NDP 2030), which highlights the importance of space, and the spatial relations between where people live and work in urban areas, as being a key hindrance to economic growth and poverty reduction (NPC 2013). The views of the NDP are reinforced in the Integrated Urban Development Framework (IUDF), which argues that the long-term prospect of having a more equal and labour absorptive economy will depend on how well its urban economies perform. This requires that our cities are well governed, and operate within a broadly enabling policy, regulatory and fiscal environment in order to directly address their development challenges- particularly related to spatial form

1.2 New approach

While the research and capacity building in the previous phase of CSP was important at the time, the new approach for this phase of the programme is to use the information and recommendations from the previous projects to build capabilities in the transport sector within local government through developing pilot projects and

collaborating with the National Department of Transport and other stakeholders to ensure that transport systems are integrated, efficient, sustainable and affordable to all users.

2. DEVEOLUTION OF PROVINCIAL BUS FUNCTIONS TO METROS

2.1 Background and Project Aim

During apartheid, public transport networks were designed to perpetuate racial segregation – their purpose was to move workers in and out of cities and towns. Bus subsidies were part of facilitating the spatial organisation of urban areas, providing cheap transport for commuters who lived in black communities located far from economic opportunities, enabling them to travel long distances to their workplaces in ‘white’ areas. This system of subsidising public transport, including buses, continues to influence – and reinforce – the historical spatial organisation of cities. It is not intentionally aligned with spatial development objectives and implicitly funds inefficiencies.

Subsequent policy and legislation, such as the National Land Transport Act (NLTA) and The Constitution, support local government taking full responsibility for public transport planning and service quality, which assumes that all functions should be devolved to that level. However, in reality, the functions remain dispersed across different spheres of government. Part of the long-term solution should be for municipalities to fully exercise their executive authority as both planning and contracting authorities for public transport.

The aim of this project is to support the practical devolution of the bus contracting function to metropolitan municipalities in line with the NLTA. This will be achieved by providing targeted and catalytic technical support to help municipalities unblock key decisions, strengthen city-led implementation and align inter-government roles. By focusing on cities that are at an advanced stage of readiness, the project seeks to enable a well-coordinated and resourced transition process that clarifies roles across government spheres, strengthens local capacity and ensures efficient, integrated bus service delivery.

2.2 Previous CSP Support

Between June 2020 and January 2022 CSP embarked on a project in conjunction with the CSIR to build an evidence-based case for effective and well-planned devolution and integration of bus functions into a public transport network, which would enable cities to become full contracting authorities in terms of the NLTA. As cities are at different stages of readiness, a toolkit was developed to assess the “readiness” of cities to comply with policies and legislation in

relation to taking over the contracting function. Each city’s readiness was “scored” against each obligation within the five categories (administrative, institutional, financial, legal and technical). The toolkit is aimed to be an interactive tool that allows cities to assess their readiness at various stages of the process.

The project objectives were:

- i. To develop a comprehensive profiling of the public transport contracting function, together with associated risks.
- ii. To establish the extent to which individual cities are ready to acquire functions.
- iii. To develop toolkits to assist municipalities at different stages of readiness to successfully acquire contracting functions.
- iv. To assist cities to implement the toolkits.

Based on the project findings and toolkit development, cities are at different stages of readiness to acquire the contracting function. It is deduced that cities have in the past been reluctant to take over the contracting function due to the lack of understanding of what is required to perform the function, coupled with the inherent risks associated with the function. The characterization that was undertaken provided cities with a better understanding of the trajectory they need to follow to become complete contracting authorities and ensures a uniform way of measuring progress across the cities

3. FURTHER CSP SUPPORT

Building on the foundation established in the previous phase of CSP, which developed a readiness assessment toolkit to help cities evaluate their capacity to take on the bus contracting function as required by the NLTA, this next phase is essential to move from assessment to implementation.

Devolution is a necessary and important step toward achieving integrated, efficient and locally responsive public transport systems. It enables municipalities—who best understand their own spatial and mobility challenges—to plan, contract and manage services in alignment with their development priorities. Without devolution, the current fragmentation across spheres of government continues to hamper effective service delivery.

The project will support selected metropolitan municipalities and national government to clarify institutional roles, assess critical risks and funding implications, and develop practical transition pathways aligned with emerging public transport funding reforms. In doing so, the project aims to strengthen inter-governmental coordination and provide a coherent foundation for future implementation of devolution

Project Objectives are as follows:

- i. Support metropolitan municipalities that are at an advanced stage of readiness—namely the City of Johannesburg, City of Cape Town and City of Tshwane—to develop decision-ready devolution support packages that consolidate existing work, identify key risks and dependencies, and outline feasible transition pathways.
- ii. Develop a practical and standardized transitional framework that clarifies the respective roles, responsibilities and sequencing requirements of national, provincial and local government during the devolution process.
- iii. Provide high-level financial, institutional and operational analysis to inform city and national decision-making, without undertaking detailed modelling, procurement documentation or implementation activities.
- iv. Support alignment between bus devolution processes and ongoing public transport funding and subsidy reforms, including the review and potential consolidation of conditional public transport grants.
- v. Facilitate structured inter-governmental engagement to strengthen coordination, resolve emerging challenges and promote a coherent national approach to bus contracting devolution.

4. SCOPE OF WORK

The CSP seeks to appoint a suitably qualified service provider to provide targeted technical support to selected metropolitan municipalities and the National Department of Transport (NDoT) to advance the operationalization of the devolution of the commuter bus contracting function, in line with the NLTA.

The appointment will be for a period of **twelve (12) months** and is intended to align with, and support, ongoing reforms to the public transport funding framework, including the review and potential consolidation of public transport conditional grants into a more integrated funding mechanism.

This phase focuses on enabling informed decision-making, institutional alignment and transition planning, rather than full implementation, recognising current fiscal constraints and the importance of ensuring that devolution is coherent with emerging funding, governance and accountability reforms.

The service provider will undertake the following key tasks:

4.1 City-Level Devolution Decision Support

Support the City of Johannesburg, City of Cape Town and City of Tshwane to develop decision-ready devolution support packages, drawing on existing studies, plans, contracts and CSP's previously developed readiness assessment toolkit.

This support will include:

- i. Assisting each City to consolidate existing information into a Devolution Position Paper that:
 - Summarises current commuter bus contracting arrangements and legal status based on current information the city has at its disposal;
 - Reflects the City's readiness profile and key capacity gaps;
 - Identifies high-level financial implications and funding considerations, including interactions with existing public transport grants;
 - Highlights key legal, institutional and operational risks;
 - Sets out a recommended devolution pathway and sequencing approach aligned with anticipated public transport

funding reforms.

- ii. Supporting Cities to develop a high-level financial and institutional snapshot, sufficient to inform decision-making and engagement with national government, without undertaking detailed financial modelling.
- iii. Developing a Critical Actions and Dependencies Map for each City, outlining:

Key actions required before, during and after devolution:

- Roles and responsibilities across spheres of government;
 - Dependencies related to grant conditions, oversight arrangements and funding reforms;
 - Decision points requiring political or administrative approval.
- iv. Supporting City engagements with internal governance structures and providing technical input to inform Council or Mayoral Committee consideration of devolution-related decisions over the 12-month project period.

4.2 Transitional Planning and Role Clarification

Support CSP, NDoT and the selected Cities to develop a practical and implementable transitional approach to devolution by:

- i. Developing a standardised Transitional Devolution Framework, applicable across cities, which:
 - Clarifies roles and responsibilities of national, provincial and local government during the transition;
 - Addresses inter-governmental coordination mechanisms;
 - Sets out principles for oversight, accountability and conditional grant alignment;
 - Responds to the evolving public transport grant reform environment, including the potential consolidation of public transport grants;
 - Identifies minimum institutional and capacity requirements during the transition period.
- ii. Preparing City-specific transition annexures that identify:
 - City-specific risks, sequencing considerations and deviations from the standard framework;
 - Key dependencies on national or provincial actions over the 12-month period.

4.3 National and Inter-Governmental Support

Provide targeted support to CSP and NDoT to strengthen alignment and coordination over the 12-months project duration by:

- i. Providing technical input to NDoT on the refinement of a practical, implementation-oriented national approach to bus devolution, with specific consideration of how devolution interfaces with public transport grant reform.
- ii. Supporting CSP and NDoT to convene and facilitate a limited number of structured inter-governmental engagements involving national, provincial and local stakeholders to:
 - Share progress and emerging lessons from participating Cities;
