1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim regarding preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) “**price**” means an amount of money tendered for goods or services and includes all applicable taxes less all unconditional discounts.
- (c) “**Rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

SPECIFICATIONS FOR ONLINE NEWSPAPER AND MAGAZINE READER SUBSCRIPTION

1. Project Title

Provision of an Online Newspaper and Magazine Reader Subscription.

2. Purpose

The purpose of this subscription is to provide the organisation with digital access to newspapers, magazines, current affairs publications, business news, sector-specific content, and archived editions to support media monitoring, research, communication, stakeholder engagement, and informed decision-making.

3. Scope of Service

The appointed service provider must supply an online newspaper and magazine reader subscription that provides access to a wide range of digital publications through a web-based and mobile-enabled platform.

The service must include:

- Access to local, national, regional, and international newspapers.
- Access to magazines across various categories.
- Access to business, finance, governance, public policy, rural development, agriculture, land, infrastructure, investment, and current affairs content.
- Access to South African publications where available.
- Access to current editions and available back issues.
- Search functionality for publications, topics, articles, keywords, dates, and categories.
- Web browser access via desktop and laptop.
- Mobile access via smartphone and tablet applications.
- Online and offline reading functionality where available.
- Article saving, bookmarking, downloading, printing, or sharing where permitted by licensing.
- Translation, text-to-speech, and accessibility features where available.
- User support, account activation, and technical assistance.

4. Required Subscription Period

The subscription must be valid for a period of 36 months from date of activation.
The bidder must also indicate renewal terms and costs where applicable.

- Land, property, infrastructure, and investment-related publications.
- Community and regional newspapers.
- International newspapers and magazines.
- Sector-specific magazines relevant to governance, development, and stakeholder relations.

7. User Access Requirements

The bidder must clearly indicate:
