nations where there are claims of mismanagement, fraud, corruption, or not meeting their responsibilities.

"That oversight function is constitutionally significant," he found. "Local government autonomy exists within a constitutional system of cooperative governance, not institutional isolation."

The report recommends that payments made to Maroga, contrary to the secondment agreement, be declared irregular, fruitless, and wasteful expenditures under the Municipal Finance Management Act. It also recommends that the undue payments identified in the mayor's September 2, 2025, letter be calculated and recovered from Maroga "without delay".

Acting corporate services director Bor-man Phutiayagae has been asked to explain the "compilation, correctness and legal basis" of his December 17, 2024, correspondence on Maroga's extended sequestration.

Additionally, the investigators suggest that Modisaotile Sam Letlakane, the speaker, clarify the differences in the council resolutions from October and December.

According to the report, Maroga was invited to respond to the allegations and to submit a written statement with supporting evidence.

For the protection and conservation of heritage sites

1. Purpose

To protect identified heritage sites by erecting a fence around them.

2. Background

The VDM Local Economic Development Strategy states that "the cultural heritage of most parts of rural South Africa is undergoing a constant process of erosion. As far as the cultural heritage is concerned, the erosion of this resource may not be so obvious but it is also an insidious process that may deprive the Venda and the Tsonga people of irreplaceable linkages to their origins and history".

The strategy further indicates that "it is not easy to produce an economic justification for the conservation of the legends; myths, indigenous knowledge systems; rituals, or oral history of a people who are being driven inexorably into a new world where survival depends largely on science and technology; but there are other reasons why a serious attempt must be made to record, protect and utilise this cultural heritage. One of the reasons is tourism, even though it is not necessarily the most important reason".

3. Expected outputs

Erect a 250m long 2.4m high **concrete palisade** fence with **razor wire** on top and one 3m long sliding **lockable** steel gate at the following heritage site:

3.1 Bungeni Heritage Site, Bungeni Village, Makhado Local Municipality.

4. POINTS AWARDED FOR SPECIFIC GOALS
