uations where there are claims of mismanagement, fraud, corruption, or not meeting their responsibilities. That oversight function is constitutionally significant, he found. Local government autonomy exists within a constitutional system of cooperative governance, not institutional isolation.

The report recommends that payments made to Maroga, contrary to the second agreement, be declared irregular, fruitless, and wasteful expenditures under the Municipal Finance Management Act. It also recommends that the undue payments identified in the mayor's September 2, 2025, letter be calculated and recovered from Maroga, without delay.

Acting corporate services director, Bor man Phuthiyagae, has been asked to explain the compilation, correctness and legal basis of his December 17, 2024, correspondence on Maroga's extended secondment.

Additionally, the investigators suggest that Mordisoetsile Sam Letlakane, the speaker, clarify the differences in the council resolutions from October and December.

According to the report, Maroga was invited to respond to the allegations and to submit a written statement with supporting evidence.

### **TERMS OF REFERENCE: REQUEST FOR PROCUREMENT OF SERVICE PROVIDERS TO CONDUCT MEDICAL SURVEILLANCE FOR A PERIOD OF 36 MONTHS (3 YEARS)**

#### **1. SCOPE OF WORK**

1.1 The service users shall be Vhembe District Municipality employees and their immediate family members (only for counselling services). The municipality has its head/post office, Disaster Centre, six fire stations spread around the district and 12 Water Services satellite offices with many water pump stations and camps around the district.

#### **2. MEDICAL SURVEILLANCE PROGRAMME**

2.1 Service Provider shall provide medical surveillance to all Vhembe District Municipality for the period of 36 months and be able to identify medical conditions that could lead to an occupational disease and also ensure compliance with regulations which require medical monitoring when employees use certain material as per section 08 of Occupational Health and Safety Act.

2.2 The service provider shall meet the following minimum requirements:

- MBChB Degree qualified as Occupational Health Medical Practitioner.
- Registered with Health Professional Council of South Africa (HPCSA). The appointed provider must submit the profile and registration certificate which should be renewed as per requirement of the council.
- Minimum experience of 03 years in the municipality or mining sector
- Certificate of Calibration Test
- Medical Certificate of fitness

2.3 The provider should be able to perform Pre-Placement Medical surveillance, Periodic Occupational Health medical surveillance and Exit medical surveillance.

2.4 Service Provider shall be able to perform the following Occupational Health Assessment amongst others:

- Eyesight Test (Colour blindness)
- Hearing Test
- Lung function (Breathing Analysis)
- Physical clinical statistics- height, weight, urine test
- Physical examinations
- Blood glucose testing (Diabetes)
- Cholesterol testing (Blood fats)
- Disclosure of lifestyle or generic conditions or diseases such as epilepsy, diabetes, high cholesterol, asthma, migraine, Hipertension, body mass index, TB, Substance abuse etc.
- Dissability and Egonomic Assesment
- Occupational Health Awareness as an when required

2.5 Should there be any hazard, risk, illness or any diseases diagnosed during the process, the employee should be provided with medical assistance and medication for the period of three (03) months, if there still need for further medical intervention, employees will utilize their own medical aids. Injury on duty cases will be dealt with as an when required.

2.6 Service provider shall provide transport, mobile clinic with all equipments required when doing outreach programme, as well as a comfortable consultation rooms around Vhembe District.

2.7 The provider shall also attend to Injury on duty cases as an when required and other second opinion medical assessments as and when requested to do so.

### **3. TRAUMA COUNSELLING SERVICES**

3.1 Service Provider shall provide counselling services on a 36 months contract to all VDM employees (individually or groups) and their immediate family members. Refferal of employees and immediade family members shall be done through Employee Wellness Programme for monitoring purpose.

3.2 The services should be provided by trained,qualified, registered and experienced professional, preferably Clinical Psychologist, registered with Health Profession Council of South Africa (HPCSA). The appointed provider must submit the profile and registration certificate which should be renewed as per requirement of the council.

- 3.3 At least 03 years of experience working for Municipality will be added advantage.
  - 3.4 No interns/ learners are allowed to render these services to the municipality.
  - 3.5 Trauma Debriefing should be made available to employees exposed to either job and personal trauma associated with incidences such as accidental injuries or fatalities, violence, death or serious injuries of co-worker, natural disaster or terrorist activities.
  - 3.6 The service provider must have a comfortable and confidential office around Vhembe District and the services be provided to clients in their own preferred language.
  - 3.7 Eight (08) face to face individual counselling sessions and 03 group sessions per should be provided.
  - 3.8 Transport will be provided for individual sessions, while group sessions, the appointed provider will use own transport to attend them anywhere across the district.
  - 3.9 The preferred bidder shall provide the municipality with individual, monthly, quarterly and annual report aligned with the financial year.
  - 3.10 Payment should only be made as per referrals only.
  - 3.11 The provider shall enter into 36 months contract with the municipality, which will outline everything including response time by the provider and administration compliance amongst others.
  - 3.12 The service Provider shall conduct organizational wellness intervention strategies such as team work structured sessions when requested to do so.
4. Service provider should have the following panel of Health professionals: 01 General Practitioner, 01 Occupational Health Medical Practitioner, 01 Clinical Psychologist, 01 Psychiatrist, 01 Occupational Therapist, 01 Physiotherapist and 01 Orthopaedic Specialist.
  5. Completed concern forms shall be submitted should there be any agreement with other providers.



**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
