- A submission submitted in response to this RFB will constitute a binding offer which will remain binding and irrevocable for a period of **one hundred and twenty (120) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFB validity period is still in force. **(RFB Validity Period: 120 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFB.
- Bidders may not make any alterations or additions to the content of this bid document, except to comply with the instructions issued by the MHSC.

INTRODUCTION TO MHSC

The Mine Health and Safety Council (MHSC) is a national public entity (schedule 3A), established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended. The MHSC is mandated to advise the Minister of Mineral Resources on Occupational Health and Safety (OHS) issues in the mining industry relating to the development and implementation of the MHSC annual OHS research programme, reviewing and development of mining OHS legislation and dissemination (knowledge and technology transfer) of MHSC research.

During the November 2024 Collieries Occupational Health Milestone Workshops, stakeholders identified poor management and maintenance of dust controls on continuous miners (CMs) as a critical occupational health and safety challenge in South African underground coal mines. CMs are a primary source of respirable coal dust, which exposes workers to serious lung diseases such as Coal Workers' Pneumoconiosis (CWP), silicosis, and chronic obstructive pulmonary disease (COPD) (NIOSH, 2011; Laney & Weissman, 2014).

Although engineering controls such as water sprays, dust collectors, canopy air curtains, and scrubber systems are in place, inadequate maintenance and management reduce their effectiveness and increase explosion risks (Colinet et al., 2010). Roof bolting further contribute to dust exposure during drilling and bolt installation activities, especially in confined, poorly ventilated underground environments (Colinet et al., 2010). Despite the deployment of various dust control technologies, their impact is often undermined by poor integration with ventilation airflow and operational practices (Schall, Cecala & O'Brien, 2015).

Recent research advocates for a holistic, systems-based approach that combines engineering controls with targeted ventilation improvements to maximize dust suppression and protect worker health (Reed et al., 2018). However, knowledge gaps remain on the practical implementation of such integrated solutions in the complex operational environments of underground coal mines.

This study therefore seeks to assess effective dust control measures on roof bolters and CMs by systematically evaluating existing practices on dust control, identifying maintenance challenges, and developing integrated controls interventions for roof bolters and CM. The ultimate goal is to enhance dust suppression effectiveness, safeguard miner respiratory health, and support the SAMI in achieving its occupational health milestones of eliminating occupational lung diseases (OLDs) through reduction of exposure to respirable dust.

1. SCOPE OF WORK/CONTEXT OF PROCUREMENT

The service provider will be required to undertake the following as part of the scope of work:

- 1.1. Conduct a comprehensive review of local and international literature to evaluate the effectiveness, performance, and integration of dust control measures applied to roof bolters and continuous miners in underground coal mines. This should include identification of best practices, gaps, and opportunities for improvement, with reference to applicable standards and guidelines.
- 1.2. Review and document the dust control technologies and practices currently applied on continuous miners and roof bolters in South African underground coal mines. Assess their effectiveness, maintenance practices, and operational limitations under varying underground conditions.
- 1.3. Undertake personal and area sampling of respirable dust during continuous miner and roof bolter operations using gravimetric and real-time monitoring instruments, in accordance with recognised local and international standards. Establish baseline exposure levels and identify high-risk activities and conditions.
- 1.4. Assess the interaction between engineering dust controls and ventilation airflow patterns, including airflow distribution and dilution effectiveness, to identify opportunities for improved dust suppression systems.
- 1.5. Analyse field data to determine key contributors to dust exposure, including equipment, operational practices, and environmental factors, and quantify their relative impact where feasible.
- 1.6. Develop practical, integrated dust control strategies that combine engineering controls, ventilation optimisation, improved maintenance practices, and any other strategies to enhance dust suppression effectiveness during continuous miner and roof bolter operations.
- 1.7. Conduct a hybrid stakeholder engagement workshop in Gauteng (hosted by the service provider) to present findings, validate results, and solicit inputs on the proposed integrated dust control strategies.
- 1.8. Develop a draft best practice guidance document to support underground coal mines in the design, implementation, operation, and maintenance of effective dust control systems for continuous miner and roof bolter operations. The guidance document should include practical, implementable recommendations,

minimum performance requirements, monitoring approaches, and alignment with applicable regulatory and compliance requirements.

- 2.6. Report on the developed practical, integrated dust controls as outlined in 1.6.
- 2.7. Report on the hybrid workshop.
- 2.8. Report on the draft guidance document.
- 2.9. Final report.
