- A submission submitted in response to this RFB will constitute a binding offer which will remain binding and irrevocable for a period of **one hundred and twenty (120) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFB validity period is still in force. **(RFB Validity Period: 120 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFB.

INTRODUCTION TO MHSC

The Mine Health and Safety Council (MHSC) is a national public entity (schedule 3A), established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended. The MHSC is mandated to advise the Minister of Mineral Resources on Occupational Health and Safety (OHS) issues in the mining industry relating to the development and implementation of the MHSC annual OHS research programme, reviewing and development of mining OHS legislation and dissemination (knowledge and technology transfer) of MHSC research.

Occupational Noise-Induced Hearing Loss (ONIHL) remains one of the most prevalent occupational diseases in the SAMI, despite the long-standing implementation of Hearing Conservation Programmes (HCPs) and regulatory requirements for noise exposure control and audiometric surveillance (MHSA, 1996; DMRE, 2016). This persistence demonstrates that current ONIHL prevention approaches are largely reactive, relying on lagging indicators such as compensable hearing loss and poorly implemented annual audiometry, which identify ONIHL only after it has occurred (MHSC, 2022).

A major weakness within the current framework is the absence of effective early-flag indicators capable of detecting escalating noise risk, ineffective controls, or early physiological and behavioural warning signs before permanent hearing loss develops (MHSC, 2022). This gap has been exacerbated by the 2016 DMRE Guidance Note on Standard Threshold Shift (STS), which misinterpreted baseline audiometry concepts and set intervention thresholds that are triggered too late to function as meaningful early-warning indicators (DMRE, 2016). The requirement for regulatory action only when STS exceeds 25 dB from baseline measured at that employer has resulted in an incorrect perception of effective NIHL control, with increasing numbers of mine workers present with hearing loss just below compensable thresholds (DMRE, 2016; MHSC, 2022).

Although subsequent guidance and legislation—including the 2022 Guideline for a Mandatory Code of Practice on Noise and the 2024 Occupational Health and Safety Act (OHSA) Noise Exposure Regulations—introduced important improvements, they retained the flawed STS framework, thereby perpetuating ineffective early detection of NIHL (MHSC, 2022; OHSA, 2024). In the absence of suitable legislated early-warning indicators, many mining operations have defaulted to using compensation-based percentage loss of hearing (PLH) thresholds as proxy indicators, despite PLH being inappropriate for preventive hearing conservation due to its emphasis on speech frequencies affected later in the progression of NIHL (DMRE, Circular 171; MHSC, 2022).

Consequently, the SAMI currently lacks a validated, practical, and implementable system of early-flag indicators to support proactive ONIHL prevention. This research seeks to identify implementable early flag indicators in screening audiometry to strengthen HCP and contribute to meaningful reductions in ONIHL across the mining industry.

1. SCOPE OF WORK/CONTEXT OF PROCUREMENT

The service provider will be required to undertake the following as part of the scope of work:

- 1.1. Conduct a review of local and international literature to understand how different countries have developed and implemented early-flag indicators in screening audiometry for the early detection and prevention of ONIHL and describe how these insights can inform the effectiveness and applicability of similar early-flag indicators for the SAMI.
- 1.2. Describe the identified early flag indicators thresholds and trigger points for early intervention, ensuring that the indicators can reliably prevent permanent hearing loss.
- 1.3. Review existing noise exposure control practices and ONIHL prevention strategies currently implemented in the SAMI.
- 1.4. Evaluate the practicality, feasibility, and effectiveness of the identified early-flag indicators for screening audiometry in selected underground and surface mining operations. The following is a proposed minimum sampling size as per Table 1:

- 1.6. Propose practical implementation guidance document aligned with Mine Health and Safety Regulations, ensuring regulatory compliance, industry applicability, and ease of adoption across diverse mining operations.

1.7. Conduct a hybrid workshop in Gauteng (hosted by the service provider) to present study outcomes and solicit inputs from relevant stakeholders.

The expected outcomes of the research are as follows:

- 2.1. A report on the literature review for all items as outlined in 1.1.
- 2.2. A report on the identified early flag indicators thresholds and trigger points as outlined in 1.2.
- 2.3. A report on the existing noise exposure control practices and ONIHL prevention strategies as outlined in 1.3.
- 2.4. A report on the practicality, feasibility, and effectiveness of the identified early-flag indicators as outlined in 1.4.
- 2.5. A report on the developed ONIHL Early-Flag Indicator Framework as outlined in 1.5.
- 2.6. A report on the practical implementation guidance document as outlined in 1.6.
- 2.7. A report on the conducted workshop as outlined in 1.7.
- 2.8. Draft final report.
- 2.9. Final report.

CONTRACT PERIOD
