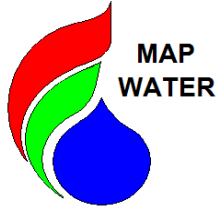

The objective is to eliminate pest infestations, improve hygiene conditions, and ensure compliance with occupational health, safety, and environmental requirements.</p> <p><b>2. - Apply approved pesticides and pest control products in accordance with manufacturer's specifications and legal requirements.
- Remove and safely dispose of dead rodents and pest-related waste where applicable.

## **2.2 Hygiene and Sanitation Services**

The contractor shall:

- Conduct deep cleaning and sanitization of affected areas.
- Disinfect areas impacted by pest infestations.
- Treat refuse storage and waste handling areas to reduce pest attraction and odors.
- Provide recommendations for improved housekeeping and hygiene practices to prevent future infestations.

## **2.3 Areas to be Covered**

The service shall include, but not be limited to:

#### **4. HEALTH, SAFETY AND ENVIRONMENTAL REQUIREMENTS**

The service provider shall:

- Comply with the Occupational Health and Safety Act, 1993 (Act 85 of 1993).
- Ensure that all employees are medically fit, competent, trained, and supervised.
- Provide and ensure the use of appropriate Personal Protective Equipment (PPE).
- Ensure safe handling, storage, transportation, and disposal of chemicals and hazardous substances.
- Prevent any environmental pollution arising from the execution of the work.
- Comply with all applicable environmental and pest control legislation.

##### **4.1 Protection of Water and Sanitation Infrastructure**

The appointed service provider shall ensure that all pest control and hygiene activities are conducted in a manner that does not compromise the quality of potable water, wastewater treatment processes, the environment, or the health and safety of employees and the public.

The service provider shall:

- Use only approved chemicals, pesticides, disinfectants, and treatment products registered in accordance with applicable South African legislation.
- Submit Safety Data Sheets (SDSs) for all chemicals and products intended for use prior to commencement of work.

- Ensure that all chemicals used are suitable for application in and around:
  - Water Treatment Works (WTWs);
  - Wastewater Treatment Works (WWTWs);
  - Reservoirs and pump stations;
  - Municipal offices and workshops;
  - Water and sanitation infrastructure.
- Prevent contamination of raw water, treated water, wastewater systems, stormwater systems, soil, and surrounding environmental areas during treatment activities.
- Ensure that bait stations, traps, pesticides, and other pest control measures are installed and maintained in a manner that do not pose a risk to employees, members of the public, domestic animals, wildlife, or water resources.
- Immediately report any spillages, leakages, contamination incidents, or environmental impacts arising from the execution of the work.
- Comply with the National Environmental Management Act, 1998 (Act 107 of 1998), and all other applicable legislation governing the use, handling, transportation, and disposal of hazardous substances.
- Provide a detailed Method Statement and Risk Assessment indicating measures to prevent contamination and environmental harm before commencement of work.

Upon completion of the service, the contractor shall provide a written declaration confirming that:

"All pest control and hygiene treatments were carried out in accordance with applicable legislation and industry best practices, and no contamination of potable water systems, wastewater systems, or municipal infrastructure occurred during the execution of the work."

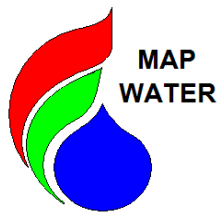

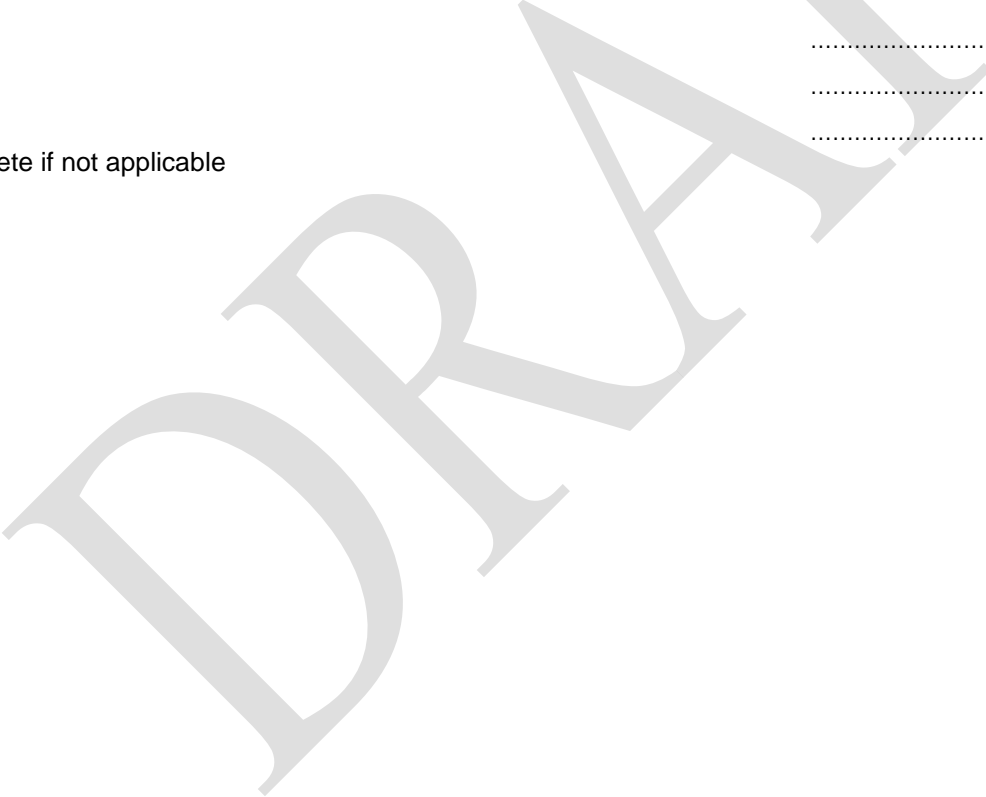
