

## **SPECIFICATION FOR THE PROVISION OF CODE 14 (EC) DRIVER'S LICENSE TRAINING TO THE AIRPORT RESCUE AND FIRE FIGHTING PERSONNEL**

### **1. PURPOSE.**

Gateway Airport Authority Limited (GAAL) seek to appoint a suitable qualified, reputable and experienced service provider for the provision of CODE 14 (EC) driver's license training to the airport rescue and firefighting personnel

### **2. BACKGROUND**

Code 14 driver's license training is a requirement in terms of National Road Traffic Act 93 of 1996 (NRTA)

We are looking to appoint a service provider (driving school) that can facilitate the process of staff members getting a code 14 driver's license.

- The service provider must be able to provide training venue and study material for learners
- The training for code 14 must be in Polokwane
- The duration of training should not exceed 90 days from the date of appointment, and the attendant register must be provided by the service provider
- The driver must be given at least three (3) times in learners license and again three (3) time chances in Practical in case he/she fails
- The facilitation process should include amongst others the bookings at the traffic department, training & learners (theory and practical) until the staff members acquires the code 14 driver's license for the following important reasons:
  - Vehicle Size and Weight – Fire pump vehicles are generally heavy and longer than regular vehicles, requiring specific skills to handle safety

- Complex Vehicle Operation – Operating pumps, managing water flow, and other firefighting equipment require additional control and awareness
- Safety – Ensuring that operators have the proper training reduces the risk of accidents during emergency responses, protecting both the driver and the public
- Legal and Regulatory Compliance – Jurisdictions mandate that drivers of certain classes of vehicle hold corresponding driver’s licenses as per local traffic and transport laws

NB: In summary, the code 14 license ensures that pump operators are legally qualified and properly trained to safely operate large fire vehicles equipped with pumps, which is critical for effective emergency response and public safety.

responses will be evaluated based on compliance with the listed administration and mandatory bid requirements. The bidder(s) quotation will be disqualified for non-submission of any of the documents.
