**1. PURPOSE**

This Request for Quotation (RFQ) is to appoint suitably qualified service provider for supply, delivery and maintenance of water coolers for a period of thirty -six (36) months at the NAC

**2. BACKGROUND**

The National Arts Council of South Africa, an Agency of the Department of Sport, Arts and Culture, is the de- facto successor in title to the Foundation for the Creative Arts, originally established in 1989. NACSA’s mandate as set out in the National Arts Council Act, Act 56 of 1997, specifies its Objectives as:

- To provide, and encourage the provision of, opportunities for persons to practice the arts
- To promote the appreciation, understanding and enjoyment of the arts
- To promote the general application of the arts in the community

- To foster the expression of national identity and consciousness by means of the arts
- To uphold and promote the right of any person to freedom in the practice of the arts
- To give the historically disadvantaged such additional help and resources as are required to give them greater access to the arts
- To address historical imbalances in providing infrastructure for the promotion of the arts
- To promote and facilitate national and international lion between individuals

### **3. SCOPE OF WORK**

The National Arts Council of South Africa (NAC) hereby invites suitably qualified service provider for the supply, delivery & maintenance of water coolers for a period of thirty-six (36) months at the NAC.

#### **3.1 Scope of work**

- Provide the Client on rental basis with 5 (Five) floor standing water coolers and dispensers with 20 litre capacity (36 months rental).
- Provide a sanitation and servicing of coolers at a minimum every six months
- Maintain and repair the coolers as and when necessary or on the request of the Client.

#### **Quantity details:**

3.1.1. Quantities: Five (5) Freestanding water coolers (hot & cold-water dispensers);

3.1.2. Quantities: 15 purified water bottles per month (size of the bottles 20 litres).

#### **3.2. Water coolers specifications**

3.2.1.1. Supply 20 litre polycarbonate bottles with handle or equivalent;

3.2.1.2. Supply stand-alone units and freestanding bottle-type;

3.2.1.3. Non-spill cap to prevent splashing;

3.2.1.4. Built-in handle reducing the risk of injury when being replaced;

3.2.1.5. Quick and easy to clean water coolers/bottles;

- 3.2.1.6. Compressor cooling capability;
- 3.2.1.7. Cooling capacity: 3.0 lt/hr at 10°C or equivalent;
- 3.2.1.8. Heating Capacity: 5.0 lt/hr at 90°C or equivalent;
- 3.2.1.9. Ambient operation temperatures: 10°C - 38°C or equivalent;
- 3.2.1.10. Cooling power consumption: 112 W or equivalent;
- 3.2.1.11. Heating power consumption: 500 W or equivalent;
- 3.2.1.12. Dimensions: 31 x 31 x 96 cm or equivalent; and
- 3.2.1.13. Net weight: 17.0 kg or equivalent.

### **3.3. Water coolers maintenance**

- 3.3.1. Maintenance of water coolers, at the Service Provider's cost, for the duration of the contract;
- 3.3.2. Free replacement of faulty water coolers by the Service Provider, for the duration of the contract, and
- 3.3.3. All the water cooler, spares/consumables used for this contract must be purchased from original suppliers and shall be brought to the site in original packing. Collection of empty bottles by the Service Provider.

### **3.4. Special conditions of the Contract**

- NAC may, at its sole discretion, award the services or any part thereof to the service provider;
- Any damage to the water coolers/bottles should be reported to NAC immediately and it will be the responsibility of the service provider to replace the damaged water coolers at no cost.
- This contract is valid for thirty-six (36) months from the effective date;
- The water coolers should have environmentally friendly cooling systems;
- All bottled water should have a visible seal when arriving at the NAC Office;
- Costs should be inclusive of VAT and annual escalation;
- Water quality certificates shall be submitted by the winning bidder immediately after delivery of the bottled water (where delivered);
- NAC will liaise with the service provider as per the quantities required for that month depending on the consumption, if additional quantities are required then the service provider will invoice NAC based on the delivered quantities for that month. If no additional water is ordered, the Service Provider will not claim the amount as part of the contract (maximum) of 15 (20L) bottles; and
- The Service Provider must indicate the validity period of warranty/guarantee applicable.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
