3. BACKGROUND

The SABC buildings in the region are more than 60 years old and require the services of a pest control company to assist in ensuring that the buildings are in a hygiene state. The Sea Point area also struggles with rats that have created several problems which include biting holes in dirt bins and chewing right through brake cables of cars.

The Pest Control Service will therefore assist in trying to maintain a pest free environment while adhering to the safety compliance hygiene and environmental regulation as per Agricultural and fertilizers Act 36 of 1947 OHS Act no 85 of 199 and Hazardous chemical substance Act 15 of 1973. This will help to provide a safe and pest free environment for all SABC Staff, contractors and visitors to the SABC buildings in the region.

4. REQUIREMENTS AND SCOPE OF SERVICES

The Service Provider will be required to provide a comprehensive Pest Control Services, which includes the following:

- Pest Control for cockroaches, fleas, bird-lice, flies – Service Monthly
 - **This must include a monthly spray/fumigation of offices, kitchens, passages, studios and garage of the SABC offices in the region. Area= 5132sqm. Due to the nature of our operations the spray/fumigation to be done after 4pm or weekends. Prior scheduling or minimum 48 hour notification to be provided.**
 - **30 x Rat Bait Stations – Services monthly, normal working hours.**
 - **18 x Sanitary Bins – Service every two weeks, normal working hours.**

4.1 SEA POINT TECHNICAL BLOCK AND MAIN BUILDING (BEACH ROAD)

- Entrance, foyers, reception area, lift, stairs, passages, kitchen, and canteen
- Offices and related areas, archives, video library, preview theatres, studio control rooms, dubbing studios and audio studios, SABC auditorium
- Toilets, bathrooms, restrooms
- Maintenance workshops and plantrooms
- HVAC plant and sump room
- Generator and UPS rooms
- Archive area in basement
- Wellness Centre / Clinic

4.2 SABC GARAGE (ROCKLANDS ROAD)

- Monthly Service and Maintenance which includes but is not limited to the following:
- Respond to callouts as and when needed
- Issuing treatment report on a monthly basis to the Logistics Manager

- Maggot's control;
- Fly extermination and control;
- Maintenance/Fumigation/Pest Control of potential infestation areas; as and when required
- Disinfection of viral infected facilities (fogging) e.g., covid-19
- Removal of dead birds, rodents or all vermin and cleaning and disinfecting
- Seasonal Bees management
- To supply and maintain bait boxes on strategic points
- Pest Control for cockroaches, fleas, bird-lice, flies

5. EQUIPMENT/S

The SABC shall not provide any equipment relating to Pest Control Services for the duration of the contract. The service provider must provide all equipment to render the service efficiently.

6. ACCESS TO THE BUILDING FOR SERVICES AND VETTING

The contractor will be granted access to the SABC buildings to render services as per the scope of work required. SABC is a National Key Point (NKP), and it is important to note that all personnel assigned to service the site will be vetted as the NKP requirement.

7. PERFORMANCE MANAGEMENT

- Once deliveries of the component, system, or service have initiated, SABC will monitor the Contractor's performance to establish a trend of Continuous Improvement.
- Quality of service or material and On-Time Delivery shall be the minimum metrics to be tracked for Contractor performance.
- Resolution of non-conformances in the service to SABC will be addressed in a manner that will best support SABC 's standard requirements.
- Expenses associated with Contractor non-conformances will be the responsibility of the Contractor.

8. KEY PERFORMANCE INDICATORS

SABC will monitor Contractor's performance and report on it on a regular basis.

- contractor's Performance Indicators are as follows:
- Service Quality: % defect free deliveries received.
- On-time delivery: % of complete service delivery and on time, based on agreed standards.
- Adherence to agreed response times.

- Contractors are expected to work with SABC to improve performance and/or process capability where needed.
- In cases of repeated poor performance or failure to improve, the contract shall be terminated at the SABC's discretion.
- Containment of Non-Conformity Supply of Service
- In the event of a non-conforming material, component, system, or service is detected, SABC or its authorized representative will determine the best method of securing conformity to meet SABC's requirements such as:
 - Return the entire lot of non-conforming material, component, or systems to Contractor.
 - Contractor to sort/rework/repair the non-conformance at SABC sites.
- SABC to identify an external resource (certified by SABC to perform, sort/rework/repair at the cost of the Contractor).

9. HEALTH, SAFETY AND ENVIRONMENT

The appointed service provider shall comply with SABC's Health and Safety Systems. All persons on company premises shall obey all health and safety rules, procedures, and practices.

NO SMOKING signs and the prohibition of the carrying of smoking materials in designated areas shall always be obeyed. The Contractor shall be fully responsible for compliance to the Occupational Health and Safety Act for all persons and equipment relating to this Contract.

Any work involving open flames sparks, cutting or heat shall be authorised by the issue of a permit to work - obtainable from the Safety department. Any work done under the protection of a permit to work shall be in strict compliance with every prescription regarding the permit.

Safety equipment shall be used where applicable (e.g. safety goggles, boots, harness, etc.) The Contractor, at his/her own expense shall provide such equipment, for his/her employees. The Contractor shall apply the necessary discipline and control to ensure compliance by his workers.

All Contractors must ensure that his/her employees are familiar with the existing emergency procedures and must co-operate in any drills or exercises, which might be held. Emergency / fire equipment and extinguishers shall not be obstructed at any time.

No person shall perform an unsafe / unhealthy act or operation whilst on Company premises. No unsafe/dangerous equipment or tools may be brought onto or used on Company premises. The Company reserves the right to inspect all equipment/tools at any time and to prevent/prohibit their use, without any penalty to the Company and without affecting the terms of the Contract in any way.

10. Validity

This bid will remain valid **90 (ninety) days** from the date of closing.

11. Costing

The indicative costing should reflect a detailed cost breakdown, and any direct or indirect costs associated with the rendering of services / supply and delivery of goods. **Refer to Annexure F – Bill of quantities**

- Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

15.4 10.4 OBJECTIVE CRITERIA

- The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay The SABC reserves the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- The SABC will not award contract/s to the bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, company financials, etc. will be eliminated from the bid process.
- The SABC reserve the right not to award this tender to any bidder who fails the financial stability assessment.
- No SABC former employees shall be awarded contracts with the SABC within **12 months** after termination of employment with the SABC.
- Should employees resign or retire from the employment of the SABC and become directors of other businesses tendering with the SABC, such tender shall not be considered until the cooling off period of 12 (**Twelve**) months has expired.
- Should the employee be dismissed from the SABC employment, such employee shall be prohibited from conducting business with SABC for a period of **5 (Five)** years from the date of dismissal.
- Should the employee be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.
- The SABC shall not procure any goods, services, works or Content from any Board member or Board member owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.
- Should the SABC's Board members no longer serve on the SABC Board but become directors of other companies, the SABC shall not conduct business with those companies until the cooling off period of **12 (Twelve)** months has expired.

- Should the Board member be found guilty in a court of law due to criminal conduct/act, such Board member will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.

16. COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

17. CONDITIONS TO BE OBSERVED WHEN TENDERING

- The corporation does not bid itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- No tender shall be deemed to have been accepted unless or until a formal contract / letter of award is signed by both parties.
- No tender shall be deemed to have been accepted unless or until a formal contract / letter of award is signed by both parties.
- **The Corporation reserves the right to:**
 - Make a selection solely on the information received in the submissions
 - Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
 - Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.
 - Cancel this RFQ or any part thereof at any time.
- Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BEE & Price.

18. Cost of Bidding

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under any circumstances be responsible or liable for any such costs, regardless of, without limitation, the outcome of the bidding, evaluation, and selection process.

19. PAYMENT TERMS

SABC will effect payment sixty (60) days after the service provider has rendered the service and submitted an invoice / statement.

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system: or
